A Regular Session of the Board of Commissioners was held at 5:30 p.m. on Tuesday, April 11th, 2017, in the City Commission Room, located in the Law Enforcement Center, 201 North Pine, with Mayor John Ketterman presiding and the following members present: Michael Gray, Jeremy Johnson, Chuck Munsell, and Patrick O'Bryan.

Mayor Ketterman led the flag salute.

ELECTION OF MAYOR – On motion of Ketterman, seconded by Munsell, the Governing Body elected Michael Gray as Mayor of the City of Pittsburg. Motion carried.

SWEARING IN OF MAYOR – The City Clerk administered the oath of office to Mayor Gray.

PRESENTATION OF CEREMONIAL GAVEL – Newly elected Mayor Gray presented a ceremonial gavel to outgoing Mayor Ketterman.

ELECTION OF PRESIDENT OF THE BOARD – On motion of Munsell, seconded by O'Bryan, the Governing Body elected Jeremy Johnson as President of the Board of the City of Pittsburg. Motion carried.

SWEARING IN OF PRESIDENT OF THE BOARD – The City Clerk administered the oath of office to President of the Board Johnson and seated him.

PUBLIC INPUT - South Homer Safe Routes to School Sidewalk Project -

Steve McGavran, a resident of Lenexa, Kansas, and owner of the business located at 2112 North Broadway, requested the sidewalk to be constructed on South Homer be re-routed to not cross Homer mid-block.

John Martell, 2307 South Homer, requested the safety of the school children, rather than the convenience of construction be considered when constructing the sidewalk on South Homer.

Gary Cunningham, 2405 South Homer, urged for better planning of the sidewalk to be constructed on South Homer.

Active Transportation Advisory Board Member LouAnn Colyer spoke in favor of the sidewalk to be constructed on South Homer.

Active Transportation Advisory Board Member John Robb, 113 West Adams, spoke in favor of the sidewalk to be constructed on South Homer and the connectivity it will provide within the City.

Active Transportation Advisory Board Member Dick Horton, 507 Norris, spoke in favor of community planning and the connectivity a sidewalk on South Homer would provide.

Phyllis Scorse, 2402 South Homer, expressed concern for the safety of children using the proposed crosswalk, citing the crosswalk's proximity to Centennial.

Commissioner Munsell expressed concern for the safety of young children crossing the street alone, in the middle of the block on South Homer.

Commissioner O'Bryan expressed concern for the location of the proposed crosswalk on South Homer. He urged City planners to revisit the design of the project to potentially re-route the crosswalk.

Director of Public Works Cameron Alden assured the Governing Body that the safety of the children was considered when the mid-block crossing was included in the planning phase of the Safe Routes to School South Homer Sidewalk Project. Mr. Alden indicated that a flashing beacon would be installed at the crosswalk site. Mr. Alden stated that it is possible to move the crossing to the intersection of Homer and Ohio.

Mayor Gray suggested if the crossing is moved to the Homer and Ohio intersection, the flashing beacon continue to be included in the project.

PUBLIC INPUT – Besse Hotel - Commissioner O'Bryan asked City Manager Daron Hall to provide an update on the Besse Hotel. Mr. Hall indicated that the City hopes to improve the operations of the Besse, with possibly a new operator.

APPROVAL OF MINUTES – MARCH 28, 2017 - On motion of Ketterman, seconded by Johnson, the Governing Body approved the March 28, 2017, City Commission Meeting minutes as submitted. Motion carried.

OFFICIAL NEWSPAPER – On motion of Ketterman, seconded by Johnson, the Governing Body approved staff recommendation to designate The Morning Sun as the official City newspaper. Motion carried.

OFFICIAL DEPOSITORIES – On motion of Ketterman, seconded by Johnson, the Governing Body approved staff recommendation to designate BMO Harris Bank, Community National Bank, Commerce Bank, Equity Bank, Labette Bank, Landmark Bank, and University Bank as official City depositories. Motion carried.

ORDINANCE NO. G1267 – On motion of Ketterman, seconded by Johnson, the Governing Body approved Ordinance No. G-1267, amending subsection (e) and subsection (f) of Section 78-33 of the Pittsburg City Code setting the maximum speed limit on Rouse Avenue between Centennial Drive and the north City limit to 35 miles per hour; reducing the speed limit from 40 miles per hour to 35 miles per hour on the sections between 1st Street to Quincy and between 11th Street and the north City limits and authorized the Mayor to sign the Ordinance on behalf of the City. Motion carried.

DISPOSITION OF BIDS – MOWING - KANSAS CITY SOUTHERN RAILROAD RIGHT-OF-WAY – On motion of Ketterman, seconded by Johnson, the Governing Body approved staff recommendation to award Martin Medina Lawn Mowing Service, of Pittsburg, Kansas, the 2017 mowing contract for the Kansas City Southern Railroad right-of-way in the amount of \$1,000.00 per scheduled mowing event, and authorized the Mayor and City Clerk to execute the contract documents once prepared. Motion carried.

DISPOSITION OF BIDS – MOWING – SOUTHEAST KANSAS RAILROAD RIGHT-OF-WAY – On motion of Ketterman, seconded by Johnson, the Governing Body approved staff recommendation to award Andrew Tractor Works, LLC, of Pittsburg, Kansas, in accordance with the Local Preference Policy, the 2017 mowing contract for the Southeast Kansas Railroad right-of-way in the amount of \$1,435.00 per scheduled mowing event, and authorized the Mayor and City Clerk to execute the contract documents once prepared. Motion carried.

DISPOSITION OF BIDS – MOWING – INDUSTRIAL PARK PROPERTIES – On motion of Ketterman, seconded by Johnson, the Governing Body approved staff recommendation to award Andrew Tractor Works, LLC, of Pittsburg, Kansas, the 2017 mowing contract for the Industrial Park properties in the amount of \$1,414.60 per scheduled mowing event, and authorized the Mayor and City Clerk to execute the contract documents once prepared. Motion carried.

DISPOSITION OF BIDS – ASPHALT CONCRETE MATERIAL – 2017 CITY SALES TAX STREET PROGRAM – On motion of Ketterman, seconded by Johnson, the Governing Body approved staff recommendation to award the bid for the provision of asphalt concrete material for the 2017 City Sales Tax Street Program and Crawford County, Kansas consisting of an estimated combined total of 17,750 tons of asphaltic concrete base and surface mix to the low bidder meeting specifications, Heckert Construction Co., Inc., of Pittsburg, based on their low bids of: \$48.92 per ton SM9.5 (Virgin Mix) Asphalt; \$47.63 per ton SM12.5 (Virgin Mix) Asphalt; \$46.43 per ton SM19A (Virgin Mix) Asphalt; and Delivery Charge of \$2.73 per ton and authorized the Mayor and City Clerk to execute the contract documents on behalf of the City of Pittsburg once prepared. Motion carried.

SURPLUS VEHICLE DECLARATION – On motion of Ketterman, seconded by Johnson, the Governing Body declared a 2000 Ford F150 as surplus and authorized staff to dispose of the vehicle through the online auction services of Purple Wave, Inc. Motion carried.

FORGIVABLE LOAN – WARE – On motion of Ketterman, seconded by Johnson, the Governing Body approved the recommendation of the Economic Development Advisory Committee (EDAC) to forgive Ron and Dora Ware's 2017 loan installment in the amount of \$5,458.88, as Mr. and Mrs. Ware have met the requirements for loan forgiveness as stipulated in their loan agreement with the City. Motion carried.

APPOINTMENT TO PITTSBURG PUBLIC LIBRARY BOARD OF TRUSTEES – On motion of Ketterman, seconded by Johnson, the Governing Body approved staff recommendation to reappoint Barbara Tims to a second four-year term and appoint Dr. Bienvenido S. Cortes to a first four-year term as members of the Pittsburg Public Library Board of Trustees effective May 1st, 2017, and to expire on April 30th, 2021. Motion carried.

CEREAL MALT BEVERAGE LICENSE – SNAK ATAK – On motion of Ketterman, seconded by Johnson, the Governing Body approved the application submitted by Mehul Shah for a 2017 Cereal Malt Beverage License for Snak Atak #5, located at 1101 East 4th Street and authorized the City Clerk to issue the license. Motion carried.

DANCE HALL LICENSE – 505 – On motion of Ketterman, seconded by Johnson, the Governing Body approved the application submitted by MLS Entertainment for a Dance Hall License for 505, located at 505 North Broadway, effective April 12th, 2017, and to expire on August 20th, 2017, and authorized the City Clerk to issue the license. Motion carried.

2017 ART WALKS – On motion of Ketterman, seconded by Johnson, the Governing Body approved staff recommendation to recognize the April 28th and August 25th, 2017, Art Walks as community events, and approved the application submitted by Kelci Cooper dba the Southeast Kansas Humane Society for a Cereal Malt Beverage license to operate a beer garden on Broadway between 5th Street and 6th Street during the two Art Walk events, with patrons under 21 to be allowed entry into the beer garden area, and authorized the City Clerk to issue the Cereal Malt Beverage license. Motion carried.

APPROPRIATION ORDINANCE – On motion of Ketterman, seconded by Johnson, the Governing Body approved the Appropriation Ordinance for the period ending April 11th, 2017, subject to the release of HUD expenditures when funds are received with the following roll call vote: Yea: Gray, Johnson, Ketterman, O'Bryan and Munsell. Motion carried.

SPECIAL PRESENTATION - DOWNTOWN ADVISORY BOARD ANNUAL REPORT - Leah Posterick, Chairman of the Downtown Advisory Board, presented the Board's annual report.

FUNDS ISSUANCE EXTENSION - LIMELIGHT MARKETING — On motion of Ketterman, seconded by Johnson, the Governing Body approved the recommendation of the Economic Development Advisory Committee (EDAC) to grant the request submitted by Brandee Johnson, owner of Limelight Marketing, to extend the time allowed to draw down the remaining \$40,000 in funding from her original loan in the amount of \$50,000 until April of 2018, and authorized the Mayor to sign the appropriate documents on behalf of the City. Motion carried.

FORGIVABLE LOAN - NPC, INTERNATIONAL - On motion of O'Bryan, seconded by Johnson, the Governing Body approved the recommendation of the Economic Development Advisory Committee (EDAC) to commit a \$50,000 forgivable loan from the Revolving Loan Fund (RLF) toward the expansion of the Pittsburg corporate NPC, International facility located at 720 West 20th Street, with \$25,000 to be forgiven in April of 2019 if NPC cerates ten new jobs and the remaining \$25,000 to be forgiven in April of 2020 if a total of fifteen jobs are created, and authorized the Mayor to sign the appropriate documents on behalf of the City. Motion carried.

ENGINEERING DESIGN AGREEMENT - NORTH WALNUT STREET EXTENSION BETWEEN 28TH STREET AND 29TH STREET - On motion of O'Bryan, seconded by Ketterman, the Governing Body approved the scope of work to be performed under the Master Services Agreement between the City and Olsson Associates for roadway design and creation of bid documents for the extension of North Walnut Street extension between 28th Street and 29th Street, at a cost not to exceed \$59,473, and authorized the Mayor and City staff to sign the appropriate documents on behalf of the City. Motion carried.

ADJOURNMENT: On motion of O'Bryan, seconded by Johnson, the Governing Body adjourned the meeting at 6:40 p.m. Motion carried.

This statute states, in part, that "before the last day of December in any year which territory has been added to or excluded from any city, the Governing Body of such city shall declare, by resolution, the entire boundary of the city."

This past year, the City of Pittsburg annexed property that was acquired from Pittsburg State University southeast of the intersection of Quincy and Rouse Streets, immediately south of Bitner's Addition. Therefore, this property will need to be included in the proposed boundary resolution for the City of Pittsburg.

RESOLUTION NO. 1196

A RESOLUTION DECLARING AND DESCRIBING THE CORPORATE LIMITS AND BOUNDARY LINES OF THE CITY OF PITTSBURG, CRAWFORD COUNTY, KANSAS.

WHEREAS, the Governing Body for the City of Pittsburg, Kansas, as authorized by the provisions of K.S.A. 12-520 did annex land within the corporate limits of the City with the adoption of Ordinance No. G-1244;

WHEREAS, pursuant to said annexation and K.S.A. 12-517, it is necessary for the Governing Body to declare the new boundary lines by resolution prior to December 31, 2016; and

WHEREAS, it is also necessary for the City Clerk to file a Certified Copy of such resolution with the Crawford County Clerk, the Crawford County Register of Deeds and the State Transportation Engineer.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF PITTSBURG, KANSAS, AS FOLLOWS:

SECTION 1. City Boundary: The corporate limits and boundary lines of the City of Pittsburg, Crawford County, Kansas, are hereby declared and described by beginning at the Northeast Corner of said City and continuing in a counter-clockwise direction as follows:

Beginning at the Northeast Corner of Section 16, Township 30 South, Range 25 East, thence West along the North line of said Section 16 to a point 636.40 feet East of the Southwest Corner of Section 9, Township 30, Range 25, thence on a bearing of North and perpendicular to said South line a distance of 40.00 feet, thence on a bearing of North 02°13'52" West a distance of 121.76 feet, thence on a bearing of North 11°47'44" West a distance of 110.36 feet, thence on a bearing of North 13°42'55" West a distance of 188.74 feet to the point of intersection with the Southeasterly right-of-way line of Old Rouse Street, thence

in a Northwesterly direction along the Southern right-of-way of the D.J. (Joe) Saia Overpass/D. J. (Joe) Saia Boulevard across the railroad right-of-way of the Kansas City Southern Railway Company and the right-of-way of the Atkinson, Topeka and Santa Fe Railway to the point of intersection with the Western rightof-way of the Atkinson, Topeka and Santa Fe Railway, thence in a Southwesterly direction along the Western right-of-way line of the Atkinson, Topeka and Santa Fe Railway to the point of intersection with the North line of Section 17, Township 30, Range 25, thence West along the North line of Section 17, to a point 291.00 feet West of the Northeast Corner of the Northwest Quarter (NW1/4) of the Northwest Quarter (NW1/4) of Section 17, thence North and parallel to the East line of the Southwest Quarter (SW1/4) of the Southwest Quarter (SW1/4) of Section 8, Township 30, Range 25 to the North line of said Southwest Quarter (SW1/4) of the Southeast Quarter (SE1/4), thence West to the Northwest Corner of the Southwest Quarter (SW1/4) of the Southwest Quarter (SW1/4) of Section 8, and continuing West on the North line of the Southeast Quarter (SE1/4) of the Southeast Quarter (SE1/4) of Section 7, Township 30, Range 25, to the Northwest Corner of the Southeast Quarter (SE1/4) of the Southeast Quarter (SE¹/₄) of Section 7, thence North along the East line of the Northwest Quarter (NW1/4) of the Southeast Quarter (SE1/4) and the Southwest Quarter (SW1/4) of the Northeast Quarter (NE1/4) to the Southeast Corner of the Northwest Quarter (NW1/4) of the Northeast Quarter (NE1/4) of Section 7, thence West along the South line of said Northwest Quarter (NW1/4) of the Northeast Quarter (NE1/4) to the center line of Cow Creek, thence in a Northwesterly and Northerly direction, along the meandering center line of Cow Creek to a point on the North line of said Section 7, said point being 625.00 feet West of the Northeast Corner of the Northwest Quarter (NW1/4) of the Northeast Quarter (NE1/4) of said Section 7, thence West along the North line of Section 7 to the Northwest Corner of the Northwest Quarter (NW1/4) of the Northeast Quarter (NE1/4) of Section 7, thence South along the West line of the Northeast Quarter (NE1/4) of Section 7 to the Southwest Corner of the Northeast Quarter (NE1/4) of Section 7, thence East along the North line of the Southeast Quarter (SE1/4) of said Section 7 a distance of 373.06 feet, thence South 1892.00 feet, thence West 30.00 feet, thence South 21.00 feet, thence West and parallel to the South line of said Section 380.00 feet, thence North and parallel to the West line of said Section 530.00 feet, thence West and running along the North line of the Southeast Quarter (SE1/4) of the Southwest Quarter (SW $\frac{1}{4}$) 1270.00 feet, thence South and running along the West line of the Southeast Quarter (SE¹/₄) of the Southwest Quarter (SW¹/₄) 666.60 feet, thence North 88°35'00" West and parallel to the South line of said Section 661.40 feet to a point being 653.40 feet North of the South line of

Yearly, the City of Pittsburg submits an application to the Kansas Housing Resources Corporation for the Emergency Solutions Grant (ESG), funding which is dedicated to homeless services. Attached, you will find the FFY 2017 ESG application for the program year starting July 1, 2017 and ending June 30, 21018. We are applying for a total of \$215,400 which will be used for Homeless Prevention, Rapid Rehousing, and Day Shelter; the Day shelter is through partnership with Wesley House, therefore they are listed as a sub-recipient in the application. The match for this grant is provided through the in-kind use of the Wesley House facility.

The requested \$215,400 will be used in the following manner:

Homeless Prevention: \$35,400

- Up to three months of rental subsidy
- Up to 2 months of rental arrears, plus fees
- Up to two months of current utilities
- Estimated 22 households will be served

Rapid Re-Housing: \$120,000

- Rental deposit
- Utility deposit
- 3 months of rent
- Utility assistance
- Estimated 76 households will be served

Day Shelter: \$60,000

- Intensive Case Management
- Access to shelter facilities
- Assistance eliminating barriers
- Estimated 45 households will be served

Projection of 76 households will qualify for rapid re-housing Services due to meeting the eligibility of being literally homeless. These households will receive housing relocation and stabilization services along with short-term rental assistance. We estimate all households will need financial assistance with rental deposit, utility deposit, along with up to 3 months of rental assistance in order to achieve stabilization. Utility assistance will also be available. Because these households have been literally homeless, we project lesser need to provide rental arrear assistance compared to household qualifying for Homeless Prevention.

The Homeless Services Case Manager will provide eligible households with referrals and coordination of other services such as health care, employment, education, and youth programs to other community providers based upon the needs identified during the initial consultation and subsequent monthly visits. The City of Pittsburg plays an active role in the Point In Time count every year. The Housing and Community Development department works as a liaison between the codes enforcement and building officials of the City's Building Services Department and the homeless service providers network to rapidly rehouse people who face homelessness due to the substandard condition of their housing. Minutes from meetings and coordination efforts are documented and distributed via email on a regular basis.

The City of Pittsburg is governed by a five member, elected Commission. One commissioner each year serves as they mayor, yet it is the entirety of the commission that votes on legislation. Activities are carried out by a City Manager, who reports to the Commission; the City Manager oversees an executive team of directors from the following departments: Police, Fire, Public Utilities, Public Works, Housing and Community Development, Economic Development, Finance, and Parks and Recreation. The finance department is responsible for financial procedures and policies, and undergo an audit yearly, including an A133. In 2016 the City was awarded an increased bond rating to AA--, and have received the Government Finance Officers Association distinguished budget Award and Comprehensive Annual Financial Report award.

- From 7/1/16-3/31/17, 40% of our day shelter clients with more than 90 days in shelter exited to permanent destinations.
- From 7/1/16-3/31/17, 78.9% of our day shelter clients with less than 90 days in shelter exited to destination other than homelessness.
- Currently there is a significant deficit of emergency sheltering in Southeast Kansas. Wesley House has identified 46 homeless individuals in Crawford County for 2017. Southeast Kansas counties such as Allen County and Montgomery County reported a total of 40 homeless individuals in 2017.
- Wesley House Day Sheltering would offer clients intensive case management, assistance through our Identification Support Program, computers for the purpose of searching for housing, jobs and to stay up to date on emails, free hot breakfast and lunch, access to the Wesley House showers and laundry facilities as well as daily storage in our day shelter lockers.
- Shelter hours are Monday-Friday from 9-4pm. Weekend and holiday food assistance is offered to clients if they choose
- Homeless case manager will be fulltime. This has helped us in trying to attain our HUD goals for 2015 and 2016. The homeless case manager is diligently working on trying to achieve the HUD goal for those who have more than 90 days in shelter. This position is a year to year contract.
- Renovation activities include updates to security cameras and basic repairs of the shelter.
- Shelter operations will involve utilities, trash, insurance, monthly security system fee, Internet, Norton, Microsoft 360 subscription.
- Monthly HOMEless events take place on the last Thursday of every month. This event features support agencies that can assist the clients with a variety of programs, a delicious hot lunch and a Blessing Bag.
- Homeless vouchers will be used for our most vulnerable homeless clients who score a 10 or above on the VISPDAT during periods of severe inclement weather. This would provide sixteen nights of shelter at a cost of \$60 per night.

All checks, financial statements and agreed upon procedures is handled though the accounting firm of Diehl, Banwart and Bolton. All checks have two signatures on it as well. There is a finance committee as well as a church treasurer at FUMC. The church does a yearly in-house audit required by the Great Plains Annual Conference; however, Wesley House is not included in this. Wesley House uses agreed upon procedures as an audit measure. Yearly, a snapshot is prepared for Wesley House as a checks and balance measure. As far as a checks and balance system, the finance committee and the Wesley House advisory committee reviews monthly statements prepared by the accounting firm. All work plans will be reviewed to ensure compliance with applicable environmental standards. The following sections briefly outline the statutory compliance areas which will affect most physical activities undertaken with CDBG funds.

Historic Properties: All properties to be rehabilitated, renovated, demolished or physically changed in any manner will be reviewed to determine if they are contained on the State of Kansas Historic List. If a structure is contained on the Historic List, rehabilitation or renovation activities must adhere to the National Secretary of the Interior's Standards for Rehabilitation. Any proposed activity which does not adhere to the Secretary of the Interior's Standards must be reviewed by the Kansas State Historic Preservation Office (SHPO) prior to commencement of the activity. All requirements outlined by SHPO and, where necessary, the Advisory Council on Historic Preservation, must be met before funds can be released. These requirements also pertain to demolition activities.

Air Quality/Asbestos Abatement: Prior to any rehabilitation, demolition or heating and ventilation improvement activity, all areas to be disturbed must be inspected for the presence of asbestos containing materials (ACM's). If asbestos is found in areas to be disturbed, all asbestos-containing materials must be completely removed by a NESHAP certified asbestos removal contractor and disposed of in accordance with all local, state and federal laws and requirements prior to the commencement of any construction or demolition work. All records documenting compliance with local, state and federal laws and regulations must be presented to the state prior to the commencement of any construction activity to obtain the release of funds. If the inspection determines that no asbestos is present in the areas to be disturbed, a signed letter stating the date of inspection and the absence of asbestos must be presented to the state.

Lead-Based Paint Abatement: Prior to the rehabilitation of any residential structure or non-dwelling facility commonly used by children under seven years, all applicable surfaces of units constructed prior to 1978 shall be inspected to determine if lead-based paint surfaces exist. If defective lead-based painted surfaces are present, notification and abatement, in accordance with all local, state and federal laws and regulations must occur prior to the release of funds. If no lead-based paint is present, a signed letter, stating the date of inspection, the name of the inspector, and the absence of lead-based paint, must be presented to the state.

Subject: Request to Waive City Bid Policy

For FY2017, the police department was allocated \$25,000 in our operating budget to purchase a deployment vehicle for the Special Response Team. It is our intention to seek a quality used vehicle that we could repurpose into a deployment vehicle, such as a fleet maintained cargo van or an emergency vehicle such as a former ambulance capable of being easily configured to transport personnel and equipment.

Under our current City Purchasing Policy, purchases over \$5,000 but less than \$20,000 require obtaining a minimum of three price quotes. Purchases in excess of \$20,000 require a formal bid process. Unfortunately, for the purchase of a specific used vehicle to meet our needs and remain within our budget allocations, obtaining multiple quotes or a formal bid from qualified vendors would not be possible.

Therefore, we are seeking permission to waive the City Purchasing Policy for an amount not to exceed \$25,000 to allow staff to seek out a used vehicle meeting our needs and specifications. It is our intention to purchase a used vehicle at a price that will leave funding for any configuration or conversion so as not to exceed the total budget allocation of \$25,000. At this time, I am currently handling over 160 felony cases. My assistant is responsible for a multitude of tasks for the entirety of each case. Some of these duties include entering all new reports into our system; electronically filing all Court documents; preparing paper files for each case; providing all discovery to Defense Counsel; uploading all discovery on the server so that I may access it remotely; issuing subpoenas for all hearings including trials; organizing and updating all paper files as new documents and/or discovery are obtained; maintaining contact with the other two County Attorney offices about various cases; and preparing all summonses and warrants. In addition, my assistant is in charge of updating my Court calendar; answering the phone and taking messages; and preparing my upcoming dockets by pulling the paper files.

Therefore, I am requesting consideration to modify our Memorandum of Understanding and move the part-time assistant position to full-time. A full-time assistant is necessary due to my extended case load as well as the fact that I am in court usually three to four days per week. My Court schedule often keeps me out of the office for long periods of time. In addition, the efficiency and effectiveness of my job relies heavily on organization and issues being handled in a timely manner. Such things are not possible without someone working closely with me on a full-time basis.

Subject: Revised Memorandum of Understanding

As you may recall, as part of the expansion of the police department through the Public Safety Sales Tax initiatives, in FY2016 the City entered into a Memorandum of Understanding with the Crawford County Attorney and the Crawford County Commission for the purpose of funding a Special Drug Prosecutor to handle the significant increase in drug cases generated by the police department's narcotics unit. In addition to the Special Drug Prosecutor, the Crawford County Attorney's Office agreed to fund a part-time assistant position assigned specifically to the Special Drug Prosecutor.

Currently we now find ourselves in a position of needing to expand the part-time position to a full-time position. The Special Drug Prosecutor has over 160 open and active felony level drug cases pending in court, with more cases being sent over almost weekly. The obvious workload associated with scheduling meetings and hearings, keeping up with case files, motions and other daily activities associated with prosecuting these complex cases necessitates moving the support position to full-time to better monitor the daily work flow. To that end, I have met with Crawford County Attorney Michael Gayoso, who agrees with the recommendation to move the position to full-time. Unfortunately, Mr. Gayoso is not in a position to expand his current staffing levels to include an additional full-time employee.

Therefore, I am respectfully requesting permission to amend the current Memorandum of Understanding so that a full-time prosecution clerk position can be added to the records division of the police department, with the City and the Crawford County Attorney splitting both salary costs and benefits of a full-time position equally, with reimbursement to the City of Pittsburg coming from the Crawford County General Fund. Should you and the Commission approve the request, we have prepared and amended Memorandum of Understanding reflecting this position change for signatures. Should you have any further questions or require further information, please contact me. I will include a memorandum prepared by Assistant County Attorney Christina Lloyd justifying the need for a full-time assistant.

MEMORANDUM OF UNDERSTANDING ADDENDUM

Between

THE CRAWFORD COUNTY ATTORNEY'S OFFICE, THE BOARD OF CRAWFORD COUNTY COMMISSIONERS, THE CITY OF PITTSBURG, KANSAS,

and

THE PITTSBURG POLICE DEPARTMENT

That the Crawford County Attorney's Office, the Board of Crawford County Commissioners, the City of Pittsburg, and the Pittsburg Police Department entered into a memorandum of understanding (MOU) to fund a full time assistant county attorney to prosecute drug cases originating within the city limits of Pittsburg, Crawford County, KS.

The parties have previously entered into a MOU and an extension of the MOU. The original MOU and the extension provided that the Crawford County Attorney's office would provide for a part-time support staff person to assist the assistant county attorney in his/her drug prosecution duties. This part-time staff person would be an employee of Crawford County.

Modification of Agreement: The city of Pittsburg has now agreed to hire a full-time support staff member to assist the ACA in his/her duties. This full-time support staff member shall be employed by the city of Pittsburg. The city of Pittsburg will be responsible for the salary and benefits for this position. Crawford county commissioners have agreed to reimburse the city of Pittsburg for one-half (½) of the total salary and benefits of the full-time support staff member from the county general fund. The specific financial transaction in reimbursing the city shall be addressed by each entities financial departments and that which would be mutually beneficial.

This addendum to the MOU is at-will and may be modified by mutual consent of the authorized officials of the Crawford County Attorney's Office, the City of Pittsburg, the Board of Crawford County Commissioners and the Pittsburg Police Department at any time during is effective dates.

This MOU shall become effective upon signature of all authorized officials.
