### BEVERAGE ONLY BOOTH INFO

1. Each booth space is 25' wide and should not be exceeded.
2. No alcoholic beverages shall be sold at anytime by vendors.
3. All exhibitors shall be responsible for their own booth, contents and meeting all health code regulations. Vendors will be responsible for maintaining and filing proper state sales tax information and for being in possession of required permits/licenses to sell drinks. Drinks are the only items that may be sold by a beverage only vendor.
4. The cost of one 25' space is \$50.00; length includes trailer tongue/ball and hitch. If the space of your trailer requires more than 25', you must purchase an additional space. Fees must be enclosed with the registration form. No space will be reserved without full payment.
5. Booth spaces will be assigned and determined upon registrations; first come, first served. Please indicate below your preference as to which side of the park you would like to be on; see attached map.
6. Vendors will be able to set up on Tuesday, July 3rd from 2:30-4:30pm or Wednesday, July 4th from 6:00-7:15am. Any vendor setting up before that time will be asked to shut down and will not be allowed to participate.
7. All applications for beverage only vendors must be received or post marked by June 15, 2018 and must include full payment for space/s and a full list of drink menu items. Applications received after June 15th will not be considered for inclusion in the celebration.

**Refunds will not be given after June 15, 2018 or in case of inclement weather.  
Applications received/postmarked after June 12th will include a \$10.00 late fee.**

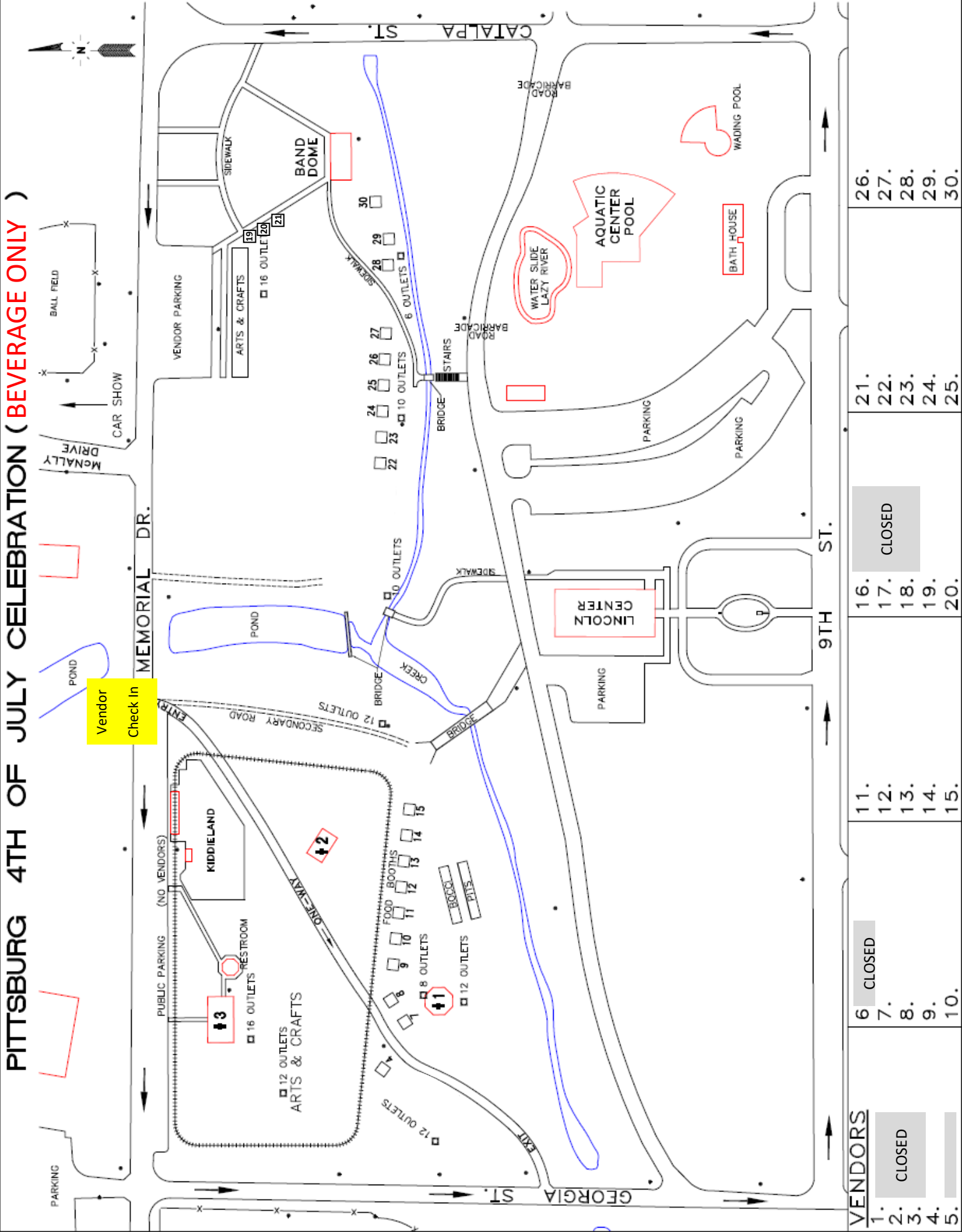
