- IV. Security 1<sup>st</sup> Title Shannon Brutchin
  - a. Discussion and information regarding tax sale properties and owner's policies of title insurance, the abstracting process, and deed preparation.
    - i. Properties received by the Pittsburg Land Bank from the tax sale cannot be issued an owner's policy of title insurance by Security 1<sup>st</sup>.
    - ii. Properties received by the Pittsburg Land Bank from the tax sale should be held as 'Class D: Banked Properties' for a period of one year from the date of the tax sale.
    - iii. Purchasers of tax sale properties are eligible to receive an owner's policy of title insurance, as long as the one year redemption period has passed.
    - iv. All parties listed on the ownership for the tax sale must receive personal service, i.e. a certified letter. The same applies for quiet titles. Any property with a listed interest who was not personally served must remain in the Land Bank for a period of 15 years before the title can be quieted and become insurable.
    - v. Deeds will now be prepared by Security 1st.
