SWEARING IN OF MAYOR – The City Clerk administered the Oath of Office to Mayor McNay and seated her.

ELECTION OF PRESIDENT OF THE BOARD – On motion of Brooks, seconded by Munsell, the Governing Body elected Commissioner Chuck Munsell as the President of the Board of Commissioners. Motion carried.

SWEARING IN OF PRESIDENT OF THE BOARD – The City Clerk administered the Oath of Office to President of the Board Munsell and seated him.

PUBLIC INPUT -

Vonnie Corsini, 1045 East 520th Avenue, thanked the members of the Governing Body and encouraged them to continue supporting heritage tourism.

Sarah Chenoweth, Pittsburg resident, spoke in opposition to Governing Body members appointing their spouses to serve on City boards and committees.

Caleb Farabi, representing the Pepsi Cola Bottling Company of Pittsburg, spoke regarding business relationship issues between the City of Pittsburg and the Pepsi Cola Bottling Company of Pittsburg.

James Bean, owner of Bean's Towing, 9436 Northeast 50th, Weir, Kansas, voiced concerns regarding the City's recent award of the bid for the Exclusive Tow Contract.

APPROVAL OF MINUTES – On motion of Brooks, seconded by Munsell, the Governing Body approved the November 26th, 2019, City Commission Meeting minutes as presented. Motion carried.

ORDINANCE NO. Motion carried.

OFFICIAL DEPOSITORIES – On motion of Brooks, seconded by Munsell, the Governing Body approved staff recommendation to designate BMO Harris Bank, Community National Bank, Commerce Bank, Equity Bank, GNBank, Labette Bank, and Landmark Bank as official City depositories. Motion carried.

OFFICIAL NEWSPAPER – On motion of Brooks, seconded by Munsell, the Governing Body approved staff recommendation to designate The Morning Sun as the official City newspaper. Motion carried.

Applicants Brad Hanson and Xavier Sheehy spoke to the Governing Body prior to the appointments.

ORDINANCE NO. S-1066 – Commissioner Brooks moved to table consideration of Ordinance No. S-1066, fixing the salary and compensation of the officers and employees of the City, to allow Governing Body members additional time to study the proposed Ordinance. The motion was seconded by Munsell. Motion failed, with Fields, McNay and O'Bryan voting in opposition.

ORDINANCE NO. S-1066 – On motion of O'Bryan, seconded by McNay, the Governing Body adopted Ordinance No. S-1066, amending Ordinance No. S-1058, fixing the salary and compensation of the officers and employees of the City of Pittsburg, Kansas. Motion carried with Brooks and Munsell voting in opposition.

DATE FOR SECOND CITY COMMISSION MEETING IN DECEMBER – On motion of O'Bryan, seconded by Munsell, the Governing Body cancelled the December 24th, 2019, City Commission Meeting. Motion carried.

NON-AGENDA REPORTS AND REQUESTS:

PURPOSE AND FORMAT OF PITTSBURG CITY COMMISSION MEETINGS - Mayor McNay discussed the proposed purpose and format of Pittsburg City Commission Meetings. It was the consensus of the Governing Body to hold a Study Session on January 25th, 2020, to further discuss the information provided by Mayor McNay, along with other information.

CASINO REVENUES – City Manager Daron Hall indicated that the casino revenues continue to increase.

RESPONSE FROM PUBLIC INPUT – FARABI – City Manager Daron Hall explained that bids were recently received for the purchase of beverages by City departments. Bids are currently being reviewed. Mr. Hall indicated that he would look into the legal aspect of Mr. Farabi's claim.

RESPONSE FROM PUBLIC INPUT – TOW CONTRACT – Mr. Hall indicated that the City is at the mercy of the bids it received for the tow contract. The notice to bidders for the tow contract was published in the newspaper and was posted on the City's web page.

LOCAL PREFERENCE – Commissioner Munsell suggested the Local Preference Policy be revisited.

ASPHALT PLANT – Commissioner Fields suggested the purchase of a small batch asphalt plant be included in the future plans for the City.

PUBLIC INPUT – Commissioner Brooks inquired if the Public Input portion of the meeting should be moved to the end of the agenda. Mayor McNay suggested this be discussed during the January 25th, 2020, Study Session.

EXECUTIVE SESSION - On motion of Munsell, seconded by Brooks, the Governing Body recessed into Executive Session for sixty minutes to discuss personnel matters of non-elected personnel pursuant to K.S.A. 75-4319(b)(1), to discuss the 2019 evaluation and 2020 employment terms and conditions for the City Manager. Motion carried.

The Governing Body recessed into Executive Session at 7:55 p.m.

The Governing Body reconvened into Regular Session at 8:39 p.m.

Mayor McNay announced that no decisions were made and no votes were taken during the Executive Session.

ADJOURNMENT: On motion on Munsell, seconded by Brooks, the Governing Body adjourned the meeting at 8:39 p.m. Motion carried.

The City of Pittsburg is required, under provisions of K.S.A. 12-517, to adopt a boundary resolution. This statute states, in part, that "before the last day of December in any year which territory has been added to or excluded from any city, the Governing Body of such city shall declare, by resolution, the entire boundary of the city."

This past year, the Carpino Ford property was added to the boundaries.

RESOLUTION NO. 1229

A RESOLUTION DECLARING AND DESCRIBING THE CORPORATE LIMITS AND BOUNDARY LINES OF THE CITY OF PITTSBURG, CRAWFORD COUNTY, KANSAS.

WHEREAS, the Governing Body for the City of Pittsburg, Kansas, as authorized by the provisions of K.S.A. 12-520 did annex land within the corporate limits of the City with the adoption of Ordinance No. G-1307;

WHEREAS, pursuant to said annexation and K.S.A. 12-517, it is necessary for the Governing Body to declare the new boundary lines by resolution prior to December 31, 2019; and

WHEREAS, it is also necessary for the City Clerk to file a Certified Copy of such resolution with the Crawford County Clerk, the Crawford County Register of Deeds and the State Transportation Engineer.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF PITTSBURG, KANSAS, AS FOLLOWS:

Water Treatment Plant Solids Contact Unit Blast & Recoat Project

Bids were received on Tuesday, December 17, 2019 for the WTP SCU Blast and Recoat Project. This project consists of constructing: the sweep blast and recoat of SCU #1 concrete walls along with the sandblast and paint of the SCU's carbon steel exposed to water, located at the City of Pittsburg Water Treatment Plant (WTP). Alternative work includes: the sweep blast and recoat of SCU #2 concrete walls along with the sandblast and paint of the SCU's carbon steel exposed to water (Add Alternative A); power washing of the stainless-steel troughs in SCU #1 (Add Alternative B); and power washing of the stainless-steel troughs in SCU #2 (Add Alternative C).

After reviewing the bids received and after checking references for the company providing the low bid, City staff is recommending awarding the bid to Cunningham Sandblasting & Painting Co., of Joplin, Missouri, based on their total bid of \$100,170.00 (Base Bid - \$49,420.00, Add Alternative A - \$46,250.00, Add Alternative B - \$2,250.00, Add Alternative C - \$2,250.00). The Engineer's Estimate is \$375,000.00.

Action necessary will be approval or disapproval of staff's recommendation and, if approved, authorize the Mayor to sign the contract documents once prepared. On December 17, 2019 bids were opened for the WTP SCU Blast & Recoat Project. The bidders and their bid amounts are shown on the attached bid tabulation. Overall, 5 bids were received, and 4 of the 5 bids were under the Engineer's estimate.

Cunningham Sandblasting & Painting Co. was the low bidder for this project. Their grand total bid amount for the Base Bid and Alternatives A, B, and C was \$100,170.00 which was below the Engineer's Estimate of \$375,000.00. A bid bond was provided. There were no addenda for the project. The bid was considered responsive.

We understand Cunningham has not performed work for the City before; however, representatives of the company visited the water plant prior to bidding and Cunningham is confident they can perform the work requested well within the time schedule allowed in the bid documents.

After discussions with internal Olsson staff who are familiar with Cunningham's prior work, as well as follow up on references that Cunningham provided, Olsson recommends that the City award the Bid for the WTP SCU Blast and Recoat Project to Cunningham Sandblasting & Painting Co. of Joplin, Missouri. The feedback on Cunningham was generally positive from all contacted and we believe they are qualified to do the work. Cunningham has been in business for many years and has the equipment and crew capacity to fulfill the work requested.

Like any project of this nature, appropriate inspection during construction is highly recommended to ensure compliance with the project specifications and overall design intent. We look forward to discussing with the City how Olsson's personnel can assist in delivering a successful project during the construction phase.

CONTRACT FOR INDUSTRIAL FIRE FIGHTING SERVICE

THIS AGREEMENT made and entered into this 14th day of January 2020, by and between the City of Pittsburg, Crawford County, Kansas, a Municipal Corporation, hereinafter called the City and S & H Management LLC, hereinafter called the Contractee, WITNESSETH:

THAT WHEREAS, the said Contractee is in charge of and handling real estate situated in Crawford County, Kansas, and located on West Fourth Street, a distance of approximately ¾ mile west of the city limits of Pittsburg, Kansas, and upon which there is located and kept various buildings used by the Contractee in the operation of manufacturing, and within a distance of five (5) miles from the limits of the City of Pittsburg.

AND, WHEREAS, the Contractee has made application to the City of Pittsburg to furnish Industrial Fire Fighting Service for said premises and property.

THEREFORE: Pursuant to the authority vested in the City, according to law, and in consideration of charges and compensation herein provided, to be paid to the City, and in consideration of their mutual covenants and promises, IT IS AGREED BY AND BETWEEN THE PARTIES HERETO, as follows:

- 1. The Fire Department of the City shall, when notified, furnish a pumper truck and a minimum of two (2) fire fighters to attend and fight fires that may occur upon the above described premises if, at the time of need for such fire, the Fire Department can spare such equipment and fire fighters. The Fire Department of the City shall make a reasonable effort to attend and extinguish such fires; but it is expressly agreed and understood that the Fire Chief or person in charge of the Fire Department shall have the right in every case to determine whether or not the City can spare any part of its Fire Department equipment and fire fighters at a particular time.
- 2. IT IS FURTHER AGREED that the City shall not be liable in any way for failure of the Fire Department to attend a fire or put out a fire, or for damages to property or persons, or for any other reason.
- 3. As compensation for such Industrial Fire Fighting Service to said premises, the Contractee agrees to pay the City of Pittsburg, Kansas, the sum of \$4,758.05 for the year beginning on the first day of January 2020. Said compensation to the City is based on the mill levy charged to City inhabitants for fire protection and/or the amount necessary to support the operation of the Fire Department. Such mill levy to be multiplied by the Contractee's assessed valuation.

Said figure then to be reduced by fifty percent (50%) and which shall be the amount charged, but in no event shall the charge be less than \$150.00 per year. The annual charge shall be recalculated each year based on succeeding City's mill levy and Contractee's assessed valuation. Said Fire Fighting Services may be extended for additional one-year periods.

4. The City, or the said Contractee, may cancel this contract by the giving of written notice thirty (30) days prior to the date on which cancellation is desired; provided, that cancellation by Contractee shall not provide for any refund of payments made.

recommendation

On November 26, 2019, the Pittsburg city commission approved \$100,000 in Revolving Loan Fund monies to support a new facility for Renu Medical & Spa (E & J Investments). Through follow-up conversations with Dr. Jacqueline Youtsos, it was discovered that the initial construction estimate did not include approximately \$20,000 to extend City utilities to the site.

As a result, the EDAC held a special meeting on December 19, 2019, to consider increasing the amount of the incentive, particularly given that the incentive amount would still fall within the 10% of total project value precedent set by previous projects. The EDAC unanimously recommended increasing the amount of the incentive package to \$120,000. As with the recommendation approved on November 26, these funds would not be expended until completion of the project and would be contingent upon the property being annexed into the City limits and a total project value of at least \$1.2 million.

Please place this item on the agenda for the City Commission meeting scheduled for Tuesday, January 15, 2020. Action being requested is approval or denial of the EDAC recommendation and, if approved, authorize the Mayor to sign the appropriate documents.

The State hereby promises, pending the execution of this agreement by the above named political subdivision, to take the necessary steps and action and to attempt to enter an agreement and any necessary amendments to obtain federal cost-sharing for that portion of the project cost referred to on the reverse side as "Fund Amount," to accept such funds from the United States and disburse the same to reimburse the local agency that portion of the total project cost that is the United States' share. It is understood by the parties hereto that this agreement shall not obligate State of Kansas funds for the project costs described herein, to execute the project or project segment described on the reverse side in accordance with the terms of the agreement. It is further understood that incurred costs will not be reimbursed without written approval that such federal funds have been encumbered.

The following special project terms and conditions were added to this agreement before the parties signed it hereto:

A final billing for reimbursement shall be submitted to the State not later than 90 days following the expiration of the project period. Failure to do so shall, at the discretion of the State, be cause for termination of the project with no further reimbursement of funds.

DEVELOPMENT PROJECTS - PERFORMANCE & ADMINISTRATION

Arrangements with Participant. It is the responsibility of the State to make arrangements with other public agencies suitable and adequate to insure successful performance of projects and to enable the continued operation and maintenance of aided facilities and properties for public outdoor recreational use. States shall assure that Participants comply with the terms of the project agreement, the provisions of the National Park Service (NPS), and all relevant laws, rules and regulations. States shall be responsible for the actions of Participants relating to the execution of projects.

PROJECT PERFORMANCE

Unless approved in advance, these items shall be submitted by the local agency to the State for processing. All items requiring NPS approval shall be sent to the State for further submittal.

- 1. <u>Performance of Construction by Contract</u>. When the total value of construction work to be performed by a contract exceeds \$25,000, the following requirements shall apply with respect to performance of the work:
 - A. <u>Bids and Awards</u>. Competitive open bidding shall be required, unless the NPS waives the requirement. When the Participant considers the lowest bidder unqualified, incapable or not responsible, the next lowest bidder may be approved. Justification for acceptance of a no-bid contract or awarding of contracts to other than the lowest bidder shall be subject to the approval of the NPS. All items requiring NPS approval should be submitted to the State for NPS submittal.
 - B. <u>Change Orders</u>. The organization involved shall issue written change orders to the contract for all necessary changes to the facility. Any change which alters the nature or purpose of the facility must be approved by the Director, NPS. Such change orders shall be filed and preserved after the completion of the project. Change orders should be made part of the project file and kept for audits.
 - C. <u>Information to be Given Bidders Concerning Federal Funds</u>. The Participant or State shall inform bidders that federal funds are being used to assist in construction. It is preferable to include this information in notices released prior to the issuance of bid invitations.
 - D. Acceptance of the Contract Work. The Participant or State has full responsibility for determining that the recreation facility is complete and ready for acceptance.
- 2. <u>Compliance With State and Local Laws</u>. Construction must comply with those State and Local laws, the violation of which may endanger the completion or utilization of the facilities. Any penalties assessed for noncompliance cannot be matched with federal funds.
- 3. <u>Compliance With Federal Laws</u>. The organization involved, and contractors shall comply with all Federal laws pertaining directly and indirectly to the proposed construction, including Executive Order 10925, as amended by the Executive Order 11114, which prohibits discrimination in employment.

ACCOUNTS & RECORDS

- Financial Responsibility. The State shall be responsible for the financial management of accepted projects. Appropriate
 internal controls must, therefore, be adopted and installed to insure that the project is accomplished in the most efficient
 and economical manner.
- 2. Accounting For Funds Received. The State shall provide such fund accounting procedures as may be necessary to assure proper disbursement and accounting for Fund monies paid to the State pursuant to the Act. The accounting procedure should be based on generally-accepted accounting standards and principles and generally meet the following minimum requirements, unless the Director, NPS agrees to exceptions:

- A. Establishment of separate accounts and supporting documents for each project. Each project account should be identified by the number assigned to the property by the NPS (i.e. 20-00600).
- B. Identification of all receipts in sufficient detail to show the source of such receipts.
- C. Itemization of all supporting records to project expenditures in sufficient detail to show the exact nature of each expenditure.
- D. Cross-referencing to each expenditure with the supporting purchase order, contract, voucher, bill, etc. These supporting documents should contain the signature of the official authorized to approve such expenditures.
- E. Maintenance of adequate records, approved by the appropriate official, to show that all salaries and wages charged against projects are authorized.
- F. Maintenance of detailed payroll vouchers (names/gross amounts) for salaries/wages.
- G. Identification of invoices/vouchers charged to project number, account number date, and expense classification.
- H. When payment is by check, the canceled check should be identified and filed, when by cash, they must be supported by receipts.
- I. Establishment of adequate internal systems of financial control following generally-accepted accounting and auditing principles.
 - The State shall require political subdivisions of public agencies, to which federal funds have been transferred, to provide similar accounting procedures as are required of the State by the NPS.
- 3. Record Retention. The financial records, including all documents to support entries on the accounting records and to substantiate charges for each project, must be kept readily available for examination by duly-authorized representatives of the NPS, the Department of Interior, and the General Accounting Office. All such records shall be retained and available for inspection.

PROJECT BILLING & DOCUMENTATION

Project billings shall be submitted to the State on the following basis unless approved in advance:

- 1. Up to \$10,000 total project cost one billing.
- 2. Up to \$50,000 total project cost no more than two billings.
- 3. Up to \$150,000 total project cost no more than three billings.
- 4. Over \$150,000 total project cost no more than four billings.
- 5. Contract land purchases one billing.

In addition the following information is required for reimbursement:

- 1. Each development project billing shall include all expenditures for items with a cost of \$25,000 or less (i.e. 100 percent item completion).
- 2. Submit one copy of all supporting documentation.
 - a. The exact nature of each expenditure.
 - b. The date the expense was incurred.
 - Evidence that the expense is chargeable to the project, copy of advertisement for bids and bid spread sheet or minutes of bid letting meeting.
 - d. Evidence that the expense has been paid, photocopies of cancelled checks.
 - e. Statement that there will be no request for sales tax refund made. Deduct any sales tax paid from total expenses.
- 3. Submit the attached claim voucher; signed, dated, include your federal ID number and the amount to be reimbursed.
- 4. Submit photos of the completed project and a legal description of the park property.

Realizing that accounting procedures and methods of paying claims varies from agency to agency, the Department realizes that photocopies may be sent in instead of original bills, invoices and/or estimates.

Any State sales tax refund received must be deducted from the total project costs.

Income that accrues to a fund-assisted area during the project period from sources other than the intended recreational use must also be deducted from the total project cost. Examples include sale or rental of buildings, sale of timber, gravel, etc.,

rental of land, and agricultural income to participant. After project period, all income should be used to further the development of the project.

FAILURE TO SUBMIT THE NECESSARY DOCUMENTATION WILL UNNECESSARILY DELAY THE ISSUANCE OF A REIMBURSEMENT WARRANT.

NOTICE

It is essential that the project be developed in conformance with the project proposal submitted and the project agreement. This is particularly true regarding the number of facilities to be constructed or installed. The Department and the NPS must approve any significant change in location or number of facilities before work can begin.

ANY DEVIATION FROM THESE INSTRUCTIONS MAY JEOPARDIZE YOUR FEDERAL ASSISTANCE ON SOME PORTION OF YOUR PROJECTS.

Policy Regarding Sexual Harassment

WHEREAS, sexual harassment and retaliation for sexual harassment claims are unacceptable forms of discrimination that must not be tolerated in the workplace; and

WHEREAS, state and federal employment discrimination laws prohibit sexual harassment and retaliation in the workplace; and

WHEREAS, officers and employees of the State of Kansas are entitled to working conditions that are free from sexual harassment, discrimination, and retaliation; and

WHEREAS, the Governor and all officers and employees of the State of Kansas should seek to foster a culture that does not tolerate sexual harassment, retaliation, and unlawful discrimination.

NOW THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby order as follows:

- All Executive Branch department and agency heads shall have available, and shall regularly review and update at least every three years or more frequently as necessary, their sexual harassment, discrimination, and retaliation policies. Such policies shall include components for confidentiality and anonymous reporting, applicability to intern positions, and training policies.
- 2. All Executive Branch department and agency heads shall ensure that their employees, interns, and contractors have been notified of the state's policy against sexual harassment, discrimination, or retaliation, and shall further ensure that such persons are aware of the procedures for submitting a complaint of sexual harassment, discrimination, or retaliation, including an anonymous complaint.
- 3. Executive Branch departments and agencies shall annually require training seminars regarding the policy against sexual harassment, discrimination, or retaliation. All employees shall complete their initial training session pursuant to this order by the end of the current fiscal year.
- 4. Within ninety (90) days of this order, all Executive Branch employees, interns, and contractors under the jurisdiction of the Office of the Governor shall be provided a written copy of the policy against sexual harassment, discrimination, and retaliation, and they shall execute a document agreeing and acknowledging that they are aware of and will comply with the policy against sexual harassment, discrimination, and retaliation.
- 5. Matters involving any elected official, department or agency head, or any appointee of the Governor may be investigated by independent legal counsel.
- 6. The Office of the Governor will require annual mandatory training seminars for all staff, employees, and interns in the office regarding the policy against sexual harassment, discrimination, and retaliation, and shall maintain a record of attendance.

- 7. Allegations of sexual harassment, discrimination, or retaliation within the Office of the Governor will be investigated promptly, and violations of law or policy shall constitute grounds for disciplinary action, including dismissal.
- 8. This Order is intended to supplement existing laws and regulations concerning sexual harassment and discrimination, and shall not be interpreted to in any way diminish such laws and regulations. The Order provides conduct requirements for covered persons, and is not intended to create any new right or benefit enforceable against the State of Kansas.
- 9. Persons seeking to report violations of this Order, or guidance regarding the application or interpretation of this Order, may contact the Office of the Governor regarding such matters.

ATTACHMENT A – LWCF GENERAL PROVISIONS

Part I - Definitions

- A. The term "NPS" or "Service" as used herein means the National Park Service, United States Department of the Interior.
- B. The term "Director" as used herein means the Director of the National Park Service, or any representative lawfully delegated the authority to act for such Director.
- C. The term "Manual" as used herein means the Land and Water Conservation Fund State Assistance Program Manual, Volume 69 (October 1, 2008).
- D. The term "project" as used herein means a Land and Water Conservation Fund grant, which is subject to the project agreement and/or its subsequent amendments.
- E. The term "State" as used herein means the State or Territory that is a party to the project agreement, and, where applicable, the political subdivision or public agency to which funds are to be transferred pursuant to this agreement. Wherever a term, condition, obligation, or requirement refers to the State, such term, condition, obligation, or requirement shall also apply to the recipient political subdivision or public agency, except where it is clear from the nature of the term, condition, obligation, or requirement that it is to apply solely to the State. For purposes of these provisions, the terms "State," "grantee," and "recipient" are deemed synonymous.
- F. The term "Secretary" as used herein means the Secretary of the Interior, or any representative lawfully delegated the authority to act for such Secretary.

Part II - Continuing Assurances

The parties to the project agreement specifically recognize that the Land and Water Conservation Fund project creates an obligation to maintain the property described in the project agreement and supporting application documentation consistent with the Land and Water Conservation Fund Act and the following requirements.

Further, it is the acknowledged intent of the parties hereto that recipients of assistance will use monies granted hereunder for the purposes of this program, and that assistance granted from the Fund will result in a net increase, commensurate at least with the Federal cost-share, in a participant's outdoor recreation.

It is intended by both parties hereto that assistance from the Fund will be added to, rather than replace or be substituted for, State and local outdoor recreation funds.

- A. The State agrees, as recipient of this assistance, that it will meet the general, special, and LWCF provisions outlined in this award agreement and that it will further impose these provisions, and the terms of the project agreement, upon any political subdivision or public agency to which funds are transferred pursuant to the project agreement. The State also agrees that it shall be responsible for compliance with the terms of the project agreement by such a political subdivision or public agency and that failure by such political subdivision or public agency to so comply shall be deemed a failure by the State to comply with the terms of this agreement.
- B. The State agrees that the property described in the project agreement and the signed and dated project

boundary map made part of that agreement is being acquired or developed with Land and Water Conservation Fund assistance, or is integral to such acquisition or development, and that, without the approval of the Secretary, it shall not be converted to other than public outdoor recreation use but shall be maintained in public outdoor recreation in perpetuity or for the term of the lease in the case of leased property. The Secretary shall approve such conversion only if it is found to be in accord with the then existing comprehensive statewide outdoor recreation plan and only upon such conditions deemed necessary to assure the substitution of other recreation properties of at least equal fair market value and of reasonably equivalent usefulness and location pursuant to Title 36 Part 59.3 of the *Code of Federal Regulations*. This replacement land then becomes subject to LWCF protection. The approval of a conversion shall be at the sole discretion of the Secretary, or his/her designee.

Prior to the completion of this project, the State and the Director may mutually alter the area described and shown in the project agreement and the signed and dated project boundary map to provide the most satisfactory public outdoor recreation unit, except that acquired parcels are afforded LWCF protection as Fund reimbursement is provided.

In the event the NPS provides Land and Water Conservation Fund assistance for the acquisition and/or development of property with full knowledge that the project is subject to reversionary rights and outstanding interests, conversion of said property to other than public outdoor recreation uses as a result of such right or interest being exercised will occur. In receipt of this approval, the State agrees to notify the Service of the potential conversion as soon as possible and to seek approval of replacement property in accord with the conditions set forth in these provisions and program regulations. The provisions of this paragraph are also applicable to: leased properties developed with Fund assistance where such lease is terminated prior to its full term due to the existence of provisions in such lease known and agreed to by the Service; and properties subject to other outstanding rights and interests that may result in a conversion when known and agreed to by the Service.

C. The State agrees that the benefit to be derived by the United States from the full compliance by the State with the terms of this agreement is the preservation, protection, and the net increase in the quality of public outdoor recreation facilities and resources which are available to the people of the State and of the United States, and such benefit exceeds to an immeasurable and unascertainable extent the amount of money furnished by the United States by way of assistance under the terms of this agreement. The State agrees that payment by the State to the United States of an amount equal to the amount of assistance extended under this agreement by the United States would be inadequate compensation to the United States for any breach by the State of this agreement.

The State further agrees, therefore, that the appropriate remedy in the event of a breach by the State of this agreement shall be the specific performance of this agreement or the submission and approval of a conversion-of-use request as described in Part II.B above.

- D. The State agrees to comply with the policies and procedures set forth in the Manual. Provisions of said Manual are incorporated into and made a part of the project agreement.
- E. The State agrees that the property and facilities described in the project agreement shall be operated and maintained as prescribed by Manual requirements and published post-completion compliance regulations (Title 36 Part 59 of the *Code of Federal Regulations*).
- F. The State agrees that a notice of the grant agreement shall be recorded in the public property records (e.g., registry of deeds or similar) of the jurisdiction in which the property is located, to the effect that the property described and shown in the scope of the project agreement and the signed and dated project boundary map made part of that agreement, has been acquired or developed with Land and

Water Conservation Fund assistance and that it cannot be converted to other than public outdoor recreation use without the written approval of the Secretary of the Interior.

G. Nondiscrimination

- By signing the LWCF agreement, the State certifies that it will comply with all Federal laws relating to nondiscrimination as outlined in the Civil Rights Assurance appearing at Article XVII.A.2 of the Grant Agreement to which these terms are attached.
- 2. The State shall not discriminate against any person on the basis of residence, except to the extent that reasonable differences in admission or other fees may be maintained on the basis of residence as set forth in the Manual.

Part III - Project Assurances

A. Project Application

- 1. The Application for Federal Assistance bearing the same project number as the Grant Agreement and associated documents is by this reference made a part of the agreement.
- 2. The State possesses legal authority to apply for the grant, and to finance and construct the proposed facilities. A resolution, motion, or similar action has been duly adopted or passed authorizing the filing of the application, including all understandings and assurances contained herein, and directing and authorizing the person identified as the official representative of the State to act in connection with the application and to provide such additional information as may be required.
- The State has the capability to finance the non-Federal share of the costs for the project.
 Sufficient funds will be available to assure effective operation and maintenance of the facilities acquired or developed by the project.

B. Project Execution

- The State shall transfer to the project sponsor identified in the Application for Federal Assistance all funds granted hereunder except those reimbursed to the State to cover eligible expenses derived from a current approved negotiated indirect cost rate agreement.
- The State will cause work on the project to start within a reasonable time after receipt of notification that funds have been approved and assure that the project will be implemented to completion with reasonable diligence.
- 3. The State will require the facility to be designed to comply with the Architectural Barriers Act of 1968 (Public Law 90-480) and DOI Section 504 Regulations (43 CFR Part 17). The State will be responsible for conducting inspections to insure compliance with these specifications by the contractor.
- The State shall secure completion of the work in accordance with approved construction plans
 and specifications, and shall secure compliance with all applicable Federal, State, and local laws
 and regulations.
- 5. In the event the project covered by the project agreement, cannot be completed in accordance

with the plans and specifications for the project, the State shall bring the project to a point of recreational usefulness agreed upon by the State and the Director or his designee in accord with Section C below.

- 6. The State will provide for and maintain competent and adequate architectural/engineering supervision and inspection at the construction site to insure that the completed work conforms with the approved plans and specifications; that it will furnish progress reports and such other information as the NPS may require.
- 7. The State will comply with the terms of Title II and Title III, the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 (P.L. 91-646), 94 Stat. 1894 (1970), and the applicable regulations and procedures implementing such Act for all real property acquisitions and where applicable shall assure that the Act has been complied with for property to be developed with assistance under the project agreement.
- 8. The State will comply with the provisions of: Executive Order (EO) 11988, relating to evaluation of flood hazards; EO 11288, relating to the prevention, control, and abatement or water pollution, and EO 11990 relating to the protection of wetlands.
- 9. The State will comply with the flood insurance purchase requirements of Section 102(a) of the Flood Disaster Protection Act of 1973, Public Law 93-234, 87 Stat. 975, approved December 31, 1976. Section 102(a) requires the purchase of flood insurance in communities where such insurance is available, as a condition for the receipt of any Federal financial assistance for construction or acquisition purposes, for use in any area that has been identified as an area having special flood hazards by the Flood Insurance Administration of the Federal Emergency Management Agency. The phrase "Federal financial assistance" includes any form of loan, grant, guaranty, insurance payment, rebate, subsidy, disaster assistance loan or grant, or any other form of direct or indirect Federal assistance.
- 10. The State will assist the NPS in its compliance with Section 106 of the National Historic Preservation Act of 1966, as amended (16 U.S.C. 470), Executive Order 11593, and the Archaeological and Historic Preservation Act of 1966 (16 U.S.C. 469a-1 et seq.) by (a) consulting with the State Historic Preservation Officer on the conduct of investigations, as necessary, to identify properties listed in or eligible for inclusion in the National Register of Historic Places that are subject to effects (see CFR Part 800.8) by the activity, and notifying the Federal grantor agency of the existence of any such properties, and by (b) complying with all requirements established by the Federal grantor agency to avoid or mitigate adverse effects upon such properties.

C. Project Termination

- 1. The Director may temporarily suspend Federal assistance under the project pending corrective action by the State or pending a decision to terminate the grant by the Service.
- 2. The State may unilaterally terminate the project at any time prior to the first payment on the project. After the initial payment, the project may be terminated, modified, or amended by the State only by mutual agreement.
- 3. The Director may terminate the project in whole, or in part, at any time before the date of completion, whenever it is determined that the grantee has failed to comply with the conditions of the grant. The Director will promptly notify the State in writing of the determination and the reasons for the termination, together with the effective date. Payments made to States or

recoveries by the Service under projects terminated for cause shall be in accord with the legal rights and liabilities of the parties.

- 4. The Director or State may terminate grants in whole, or in part at any time before the date of completion, when both parties agree that the continuation of the project would not produce beneficial results commensurate with the further expenditure of funds. The two parties shall agree upon the termination conditions, including the effective date and, in the case of partial termination, the portion to be terminated. The grantee shall not incur new obligations for the terminated portion after the effective date, and shall cancel as many outstanding obligations as possible. The NPS may allow full credit to the State for the Federal share of the non-cancelable obligations, properly incurred by the grantee prior to termination.
- 5. Termination either for cause or for convenience requires that the project in question be brought to a state of recreational usefulness agreed upon by the State and the Director or that all funds provided by the National Park Service be returned.

D. Project Closeout

- The State will determine that all applicable administrative actions, including financial, and all
 required work as described in the project agreement has been completed by the end of the
 project's period of performance.
- 2. Within 90 calendar days after completing the project or following the Expiration Date of the period of performance, whichever comes first, the State will submit all required documentation as outlined in the Manual and the Federal Financial Report (SF-425) as outlined in Article XIV of this Agreement for approval by the Service prior to requesting final reimbursement.
- After review, including any adjustments, and approval from the NPS, the State will request through ASAP the final allowable reimbursable costs. Upon completion of an electronic payment, the State will submit a completed "LWCF Record of Electronic Payment" form to the NPS.
- 4. The NPS retains the right to disallow costs and recover funds on the basis of later audit or other review within the record retention period.

LIVE WELL CRAWFORD COUNTY/CITY OF PITTSBURG MEMORANDUM OF UNDERSTANDING RESIDENT/COMMUNITY WELL-BEING

This Memorandum of Understanding is made this 14th day of January, 2020, between Live Well Crawford County (hereinafter "LWCC"), and the City of Pittsburg, Kansas (hereinafter the "City"). The Parties to this Memorandum of Understanding, in consideration of the mutual covenants and stipulations set forth herein, agree to as follows:

WHEREAS, LWCC agreed to transfer to the City one-hundred thousand dollars (\$100,000) from their BlueCross and BlueShield of Kansas Pathways to a Healthy Kansas grant funding and the City agreed to improve infrastructure for active transportation to the North Medical District; and

WHEREAS, on July 9, 2019 the Pittsburg City Commission adopted Resolution No. 1223 adopting the "Sidewalk Feasibility Study North Medical District"; and

WHEREAS, City staff and the Active Transportation Advisory Board will recommend the route and propose the use of the \$100,000 towards implementation of the project to the City Commission; and

NOW THEREFORE, the parties agree to cooperate with each other as follows:

- 1. **Purpose of the Project.** LWCC shall transfer one-hundred thousand dollars (\$100,000) to the City of Pittsburg to be utilized solely for infrastructure enhancements for active transportation to the North Medical District.
- 2. **Term and Effective Date.** This Memorandum of Understanding will begin on and be effective January 14, 2020. Beginning on this date, the Memorandum of Understanding will endure as long as the infrastructure is in place.
- 3. **Construction Responsibilities**. The City shall be solely responsible for all construction decisions and costs for the infrastructure.
- 4. **Maintenance.** The City shall be responsible for the long-term maintenance and upkeep of the infrastructure.
