

OFFICIAL MINUTES
OF THE MEETING OF THE

December 1, 2020

A Regular Session of the Active Transportation Advisory Board was held at 12:00 p.m. on Tuesday, December 1, 2020 at City Hall or via Go-To Meeting, Chairperson - Darrell Pulliam, John Robb, Dick Horton, Reno Cecora and Erin Fletcher were present as well as Kim Vogel, Director of Parks and Recreation and Cameron Alden as staff liaisons, Vice Chairperson – Debra Anthony, Deborah McGeorge, was not in attendance.

APPROVAL OF MINUTES – November 3, 2020 – The meeting was called to order at 12:05 p.m. On motion of Horton, seconded by Cecora, the minutes of November 3, 2020 were approved as submitted.

PROJECT UPDATES – Cameron Alden gave a brief update on the North Medical District sidewalk project, the East Quincy Road Project, and the Railroad track project. The 4th Street Bridge Project is a KDOT project and at this time Cameron doesn't have an update.

SUSTAINABILITY – The metrics tracking is a still a work in progress and will get sent out to the group as soon as it gets set up.

MARKETING – There was no new update at this time.

SAFETY CONCERNS FROM QUADRANTS – There were no new concerns at this time.

ANNUAL REPORT TO GOVERNING BODY – With the current conditions, the City Manager is trying to keep additional people out of the public meetings. Cameron suggested the group draft a letter to present to the Governing Body. Darrell Pulliam will draft a letter and then circulate it among the group to send to the Governing Body.

- S. Broadway Corridor

This item will be discussed at the next meeting.

2021 TENTATIVELY SCHEDULED MEETINGS – After a brief review, Fletcher moved, seconded by Cecora to approve the schedule as submitted.

OTHER BUSINESS – It was decided to wait until the January meeting to appoint a Chairperson and Vice Chairperson.

There was one new application submitted to set the Board. Cameron recognized Richard Horton and thanked him for his service to the Board.

ADJOURNMENT – There being no further business, Robb moved, seconded by Fletcher to adjourn the meeting at 12:30 p.m. The next tentatively scheduled meeting has been set for January 5, 2021.
