Mayor Brooks led the flag salute.

INVOCATION – Father Chris Rumback, on behalf of Our Lady of Lourdes, provided an invocation.

PUBLIC INPUT – Mr. Al Patel invited members of the Governing Body to attend a Diwali celebration on October 29th, 2022, at the Overman Student Center on the Pittsburg State University campus.

APPROVAL OF MINUTES – On motion of McNay, seconded by Hite, the Governing Body approved the October 11, 2022, City Commission Meeting minutes as presented. Motion carried.

ORDINANCE NO. S-1090

AN ORDINANCE granting an ad valorem tax exemption to Atkinson Industries, Inc., pursuant to the City of Pittsburg's Policy and Procedures adopted November 10, 1987, as authorized by Section 13, Article 11, of the Constitution of the State of Kansas.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PITTSBURG, KANSAS:

Section 1: In accordance with the City's Policy and Procedures adopted on November 10, 1987, the Governing Body finds that the City has received the tax exemption application fee of \$250.00, has published notice in the official city newspaper at least seven (7) days prior to this date, has held the hearing as stated in said notice, the costs and benefits analysis has been completed and reviewed, and has received a favorable recommendation from the Economic Development Revolving Loan Fund (Sales Tax) Advisory Committee relating to the request of Atkinson Industries, Inc., for an ad valorem tax exemption on the following improvements located at 1801 E. 27th Terrace, Crawford County, Kansas:

A part of Lot Six (6) in the Replat of Pittsburg Regional Industrial Park, Pittsburg, Crawford County, Kansas, more particularly described as follows:

Beginning at the Northwest corner of said lot 6, said point of beginning being on the East right of way line of the Missouri-Pacific Railroad, thence South 89°28'36", East 695.72 feet along the North line of said lot 6 to a point 500 feet West of the Northeast corner of said lot 6, said Northeast corner being on the centerline of North Rotary Terrace, thence South 0°01'42" West and parallel to the East line of said lot 6, 720.06 feet to the North right of way line of 27th Street Terrace, thence Southwesterly around a curve concave to the left with a radius of 1,230.37 feet and an intersection angle of 22°58'58" a distance of 493.53 feet to the point of tangent on the North right of way line of said 27th Street Terrace, thence South 64°09'43" West and along said North right of way line of 27th Street Terrace 259.86 feet, thence North 0°46'43" East 961.12 feet to the point of beginning.

<u>REAL PROPERTY AND IMPROVEMENTS:</u> See that part of the Atkinson Industries, Inc., tax exemption application marked and attached hereto as Attachment A which is incorporated herein by reference.

Section 2: For good and sufficient reasons, including the findings that it is in the best interests of the public welfare, that the property for which the exemption is granted will be used exclusively for the purposes specified in Section 13 of Article 11 of the Kansas Constitution, and that the recommendation of the Economic Development Revolving Loan Fund (Sales Tax) Advisory Committee should be accepted, Atkinson Industries, Inc., is hereby granted an ad valorem tax exemption starting with the 2023 tax year on said real estate, personal property and improvements for a period of up to seven (7) years subject to the following criteria and conditions:

- a) Atkinson Industries, Inc., make a payment in lieu based upon the aforesaid real estate as the same existed and was valued for the most recent year prior to completing the aforesaid improvements (a copy of the assessment sheets for that year being attached hereto) in accordance with Section 9 of the City's said Policy and Procedures;
- b) Atkinson Industries, Inc., submit the necessary information and a renewal application signed by a duly authorized representative of Atkinson Industries, Inc., prior to February 1st of each year for the City to annually review the tax exemption/incentive pursuant to the schedule set forth in Section 15 of said Policy and Procedures, a copy of which has been received by Atkinson Industries, Inc.; and
- c) Atkinson Industries, Inc., pay the annual renewal fee of \$100.00 and continue to be in compliance with the conditions and provisions of said Policy and Procedures.
- Section 3: Upon receipt of the exemption application to be filed with the County Appraiser, the City Clerk shall provide Atkinson Industries, Inc., with a published copy of this Ordinance for the applicant's use in filing its initial request for the tax exemption.

Section 4: This Ordinance shall take effect from and after its passage and its publication

SECOND AMENDMENT TO ANTENNA COLLOCATION LEASE AGREEMENT

THIS SECOND AMENDMENT TO ANTENNA COLLOCATION LEASE AGREEMENT ("Amendment") is made and entered into by and between the City of Pittsburg, Kansas, a municipal corporation ("Lessor"), and T-Mobile Central LLC, a Delaware limited liability company ("Lessee").

Recitals

The parties hereto recite, declare and agree as follows:

- A. Lessor and Lessee (or as applicable, their respective predecessors in interest) entered into a Antenna Collocation Lease Agreement dated February 12, 2002 (including any prior amendments, the "Lease"), with respect to Premises located at 420 E 22nd Street, Pittsburg, Kansas 66762.
- B. Lessor and Lessee desire to enter into this Second Amendment in order to modify and amend certain provisions of the Antenna Collocation Lease Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lessor and Lessee covenant and agree as follows:

- 1. Effective as of _______, 20___, Lessee will have the right to modify its Antenna Facilities as described and depicted on Exhibit A, which is attached hereto and by this reference incorporated herein, and Lessor hereby consents to and approves of the modifications described and depicted on Exhibit A in all respects.


- 3. The terms and conditions of the Antenna Collocation Lease Agreement are incorporated herein by this reference, and capitalized terms used in this Second Amendment shall have the same meanings such terms are given in the Antenna Collocation Lease Agreement. Except as specifically set forth herein, this Second Amendment shall in no way modify, alter or amend the remaining terms of the Antenna Collocation Lease Agreement, all of which are ratified by the parties and shall remain in full force and effect. To the extent there is any conflict between the terms and conditions of the Antenna Collocation Lease Agreement and this Second Amendment, the terms and conditions of this Second Amendment will govern and control.
- 4. Lessor represents and warrants to Lessee that the consent or approval of no third party, including, without limitation, a lender, is required with respect to the execution of this Second

Amendment, or if any such third party consent or approval is required, Lessor has obtained any and all such consents or approvals.

MT. OLIVE CEMETERY SERVICES AGREEMENT

This MT. OLIVE CEMETERY SERVICES AGREEMENT (this "<u>Agreement</u>") is made as of [_____], 2022, by and between the City of Pittsburg, Kansas ("City") and Notch8.llc.

RECITALS:

WHEREAS, City wishes to hire Notch8.llc to provide maintenance and repair services at the Mt. Olive Cemetery ("Cemetery") in a manner satisfactory to both parties;

WHEREAS, City will allow Notch8.llc to use all of City's assets, vehicles, tools and equipment currently used in the maintenance and repair of the Cemetery, See Exhibit B for a partial list of tools and equipment currently used by the City to maintain and repair the Cemetery;

WHEREAS, each party understands that the Services provided hereunder will be done in such a manner as to improve the overall condition of the Cemetery for the benefit of the City and its citizens.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

ARTICLE 1 CERTAIN DEFINITIONS

As used in this Agreement the following terms have the respective meanings set forth below.

- "Agreement" has the meaning set forth in the introductory paragraph of this Agreement.
- "<u>Dispute</u>" has the meaning set forth in <u>Section 0</u> of this Agreement.
- "Invoice Period" has the meaning set forth in Section 3.2 of this Agreement.
- "Notice" has the meaning set forth in Section 0 of this Agreement.
- "Services" has the meaning set forth in Section 2.1 of this Agreement.
- "Personnel" means the Team Members, agents and contractors of a respective party to this Agreement.
- "Material" means rock and fill dirt.

ARTICLE 2 SERVICES TO BE PROVIDED

- 2.1 <u>Services</u>. The parties hereto agree that, upon the terms and subject to the conditions set forth in this Agreement, Notch8.llc shall provide to City the services described on <u>Exhibit A</u> (the "<u>Services</u>") solely in connection with the maintenance and repair of the Cemetery.
- 2.2 <u>Term.</u> The Services shall be provided for a 5-year term starting on the Agreement Date, subject to earlier termination pursuant to <u>Section 5.1</u>. At the end of the initial 5-year term this Agreement may be extended at the mutual consent of the Parties.
- 2.3 <u>Cooperation and Project Managers.</u> City shall cooperate fully and provide such assistance as is reasonably required for Notch8.llc to provide the Services in the manner required by this Agreement. This cooperation will include the appointment by each party hereto of one or more persons to serve as such party's representative(s) to deal with issues arising out of the performance of this Agreement and facilitate the orderly provision of the Services. The initial representatives shall be as follows:

Either party may change its designated representative(s) or the contact information for such designated representative(s) by giving Notice to the other party.

- 2.4 <u>Subcontractors</u>. Notch8.llc may delegate or sub-contract their duties under this Agreement; provided, however, that such delegation or subcontracting shall not relieve Notch8.llc of any of their obligations under the Agreement.
- 2.5 <u>Personnel</u>. All labor matters relating to Personnel of any party or its Affiliates (including, without limitation, Personnel involved in the provision of the Services) shall be within the exclusive control of such party, and the other party shall not have any responsibility with respect to such matters. All Personnel and representatives of Notch8.llc providing Services hereunder shall not be deemed to be Personnel or representatives of City, and Notch8.llc shall be responsible for all compensation and any withholding and payment of Taxes for such Personnel and representatives.
- 2.6 <u>Control of Operations</u>. Notwithstanding anything herein to the contrary, as between Notch8.llc and the City, Notch8.llc shall have exclusive control of the planning and execution of the Services at all times.

2.7 <u>Services Subject to Legal Requirements</u>. Nothing herein shall be construed to require any Personnel to provide any Service in violation of any law, rule or regulation to which such Personnel is subject, nor to require any Personnel to violate or breach any contract or agreement to which such Personnel is subject.

ARTICLE 3 COMPENSATION AND PAYMENT TERMS

- 3.1 <u>Compensation for Services</u>. In consideration of the provision of the Services pursuant to this Agreement, Notch8.llc shall be entitled to be compensated as set forth on Exhibit A.
- 3.2 <u>Payment</u>. On or before the tenth (10th) day of each calendar month, Notch8.llc shall deliver to the City an invoice reflecting the amount due under this Agreement for the Services provided by Notch8.llc in the previous month. Attached to each invoice shall be an itemization of the Services supplied during the previous month (or, with respect to the initial and last months, any portion thereof) (the "<u>Invoice Period</u>") and an explanation, in reasonable detail, of the amount due in respect of each Service. Subject to <u>Section 9.4</u>, City shall make payment of the amount due to Notch8.llc on any invoice within twenty (20) days after City's receipt of the invoice. Each invoice shall be subject to audit by City, at City's sole cost and expense, within sixty (60) days following City's receipt of such invoice.
- 3.3 No Right of Offset. Neither party shall have a right to offset, deduct or withhold any monies from any amounts due under this Agreement based on any amounts owed or claimed to be owed by the other party.

ARTICLE 4 STANDARD OF SERVICE

- 4.1 <u>Standard of Service</u>. The Parties agree to work together to establish reasonable Standard of Service that will achieve the improvements desired to the Cemetery over time.
- 4.2 <u>City Assistance</u>. City acknowledges that certain Services to be provided by Notch8.llc are dependent upon assistance to be provided by City. The parties acknowledge that certain Services may be dependent upon, or may be optimized with, the use of material provided by the City and the City agrees to provide that material in a commercially reasonable manner.

ARTICLE 5 TERMINATION

- 5.1 <u>Termination</u>. This Agreement may be terminated in whole or in part as follows:
- (a) Either party may terminate this Agreement at the end of the initial 5-year term.
- (b) Either party may terminate this Agreement prior to the end of the initial 5-year term in one or more of the following circumstances:

- (1) if Notch8.llc and City agree in writing; or
- (2) if one party shall commit a material breach of one or more of its obligations under this Agreement, and the other party has provided notice of such material breach and the breach is not cured or remedied within thirty (30) days following the date of giving notice.
- 5.2 <u>Effect of Termination</u>. Upon termination of this Agreement, all rights and obligations of each party hereunder shall cease as of the date of the termination except for the parties' rights and obligations under <u>ARTICLE 3</u> and <u>ARTICLE 6</u>, which shall survive termination of this Agreement. Notwithstanding the foregoing, the termination of this Agreement pursuant to any of the provisions hereof shall be without prejudice to any rights, or diminution of any obligation or liability of either party, that may have accrued prior to the effective date of such termination.

ARTICLE 6WARRANTY, LIABILITY AND INDEMNITY

- 6.1 <u>Disclaimer of Warranties</u>. Except as expressly herein provided (including the standard of service contained in Section 4.1), the services are provided "as is," "where is" and "with all faults as to all matters" and Notch8.llc and their affiliates expressly disclaim and negate any representation or warranty, express, implied, at common law, by statute or otherwise relating to (a) the services (including, without limitation, any implied or express warranty of merchantability, of fitness for a particular purpose or of conformity to models or samples of materials).
- 6.2 <u>Indemnity; Release</u>. To the fullest extent permitted by law, Notch8.llc shall indemnify, defend and hold harmless the City and the City's representatives, officers, directors, employees and agents (collectively, "City Indemnitees") from and against any and all claims, liabilities, fines, penalties, costs, damages, losses, liens, causes of action, suits, demands, judgments and expenses (including, without limitation, court costs, attorneys' fees and costs of any nature, kind or description directly or indirectly arising out of, resulting from or related to (in whole or in part) this agreement, to the extent caused by the negligence or willful misconduct of Notch8.llc and its Personnel.
- 6.3 Indemnity; Release. To the fullest extent permitted by law, the City shall indemnify, defend and hold harmless Notch8.llc and Notch8.llc's representatives, officers, directors, Team Members and agents (collectively, "Notch8.llc Indemnitees") from and against any and all claims, liabilities, fines, penalties, costs, damages, losses, liens, causes of action, suits, demands, judgments and expenses (including, without limitation, court costs, attorneys' fees and costs of any nature, kind or description directly or indirectly arising out of, resulting from or related to (in whole or in part) this Agreement, to the extent caused by the negligence or willful misconduct of the City and its Personnel.

ARTICLE 7 INSURANCE

Each party shall, throughout the term of this Agreement, carry insurance with commercially reasonable coverage levels with a reputable insurance company or companies covering property

damage and general liability (including contractual liability) to protect their own business and property interests.

ARTICLE 8 FORCE MAJEURE

If Notch8.llc are rendered unable, wholly or in part, by force majeure to carry out their obligations under this Agreement, Notch8.llc shall give City prompt written notice of the force majeure with reasonably full particulars, including, without limitation, Notch8.llc's best estimate of the duration of such force majeure; thereupon, the obligations of Notch8.llc giving notice, insofar as they are affected by force majeure, shall be suspended during, but no longer than, the continuance of the force majeure. Notch8.llc will use commercially reasonable efforts to remove the force majeure situation; provided, however, that Notch8.llc shall not be required to hire additional personnel or contract workers, or to settle strikes, lockouts, or other labor difficulty, contrary to their wishes; and the handling of such difficulties shall be entirely within the reasonable discretion of Notch8.llc. The term "force majeure" as used herein shall mean an act of God, strike, lockout, or other industrial disturbance, act of the public enemy, war, blockade, insurrection, public riot, epidemic, landslide, lightning, fire, storm, flood, explosion, governmental action, governmental delay, restraint or inaction, unavailability of equipment, and any other cause, whether of the kind specifically enumerated above or otherwise, which is not reasonably within the control of Notch8.llc.

ARTICLE 9 MISCELLANEOUS

- 9.1 No Agency. Notch8.llc shall provide the Services as an independent contractor, and nothing in this Agreement shall constitute or be deemed to constitute a partnership or joint venture between the parties or constitute or be deemed to constitute either party or Personnel of the other for any purpose whatsoever, and neither party shall have authority or power to bind the other or to contract in the name of, or create a liability against, the other in any way or for any purpose.
- 9.2 Confidentiality. Subject to applicable laws, rules and regulations, each of City and Notch8.llc (including their respective Team Members, agents, representatives and Affiliates) shall maintain in confidence all proprietary and confidential business information of the other party to which it might become privy as a result of the transactions contemplated herein. No restrictions are placed upon a party hereto with respect to the use or disclosure of any such information that: (i) is or becomes through no fault of the receiving party within the public domain; (ii) was legally acquired by the receiving party from an unaffiliated third party who had a right to convey the same without obligation of secrecy; or (iii) is required to be disclosed by binding court order or other requirements of laws.
- 9.3 Assets, Books and Records. Promptly following the earlier of the termination or expiration of this Agreement, Notch8.llc shall, and shall cause their representatives and Affiliates to, deliver to City all remaining assets, books, records and data related to the Cemetery.

- 9.4 <u>Dispute</u>. Either party may at any time deliver a notice to the other party pursuant to <u>Section 0</u> hereof setting forth any dispute, controversy or claim arising out of or in connection with, or relating to, this Agreement or any breach or alleged breach hereof ("<u>Dispute</u>"). Following receipt of such notice, the parties shall negotiate in good faith to resolve such Dispute within a period of fifteen (15) days (or such longer period of time as the parties may agree in writing).
- 9.5 Notices. All notices, requests, demands, and other communications required or permitted to be given or made hereunder by any party (each a "Notice") shall be in writing and shall be deemed to have been duly given or made if (i) delivered personally, (ii) transmitted by first class registered or certified mail, postage prepaid, return receipt requested, (iii) delivered by prepaid overnight courier service, (iv) delivered by confirmed facsimile transmission or (v) delivered by Email to the Parties at the following addresses (or at such other addresses as shall be specified by the Parties by similar notice):

Notices shall be effective (i) if delivered personally or sent by courier service, upon actual receipt by the intended recipient, (ii) if mailed, upon the earlier of five days after deposit in the mail or the date of delivery as shown by the return receipt therefor, or (iii) if sent by facsimile or e-mail transmission, upon the date sent by facsimile or e-mail of a PDF document (with confirmation of transmission) if sent during normal business hours of the recipient, and on the next business day if sent after normal business hours of the recipient.

- 9.5 Severability. Should any provision of this Agreement for any reason be declared invalid or unenforceable, such decision shall not affect the validity or enforceability of any of the other provisions of this Agreement, which remaining provisions shall remain in full force and effect and the application of such invalid or unenforceable provision to persons or circumstances other than those as to which it is held invalid or unenforceable shall be valid and enforced to the fullest extent permitted by law.
- 9.6 Binding Effect; Assignment. This Agreement and all of the provisions hereof shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and permitted assigns. Neither this Agreement nor any of the rights, interests or obligations

hereunder shall be assigned, directly or indirectly, including, without limitation, by operation of law, by any party hereto without the prior written consent of the other parties hereto; provided, however, that Notch8.llc may subcontract the performance of any Service to a third party to the extent provided herein.

- 9.7 No Third-Party Beneficiaries. This Agreement is solely for the benefit of Notch8.llc and their successors and permitted assigns, with respect to the obligations of City under this Agreement, and for the benefit of City and its successors and permitted assigns, with respect to the obligations of Notch8.llc under this Agreement, and this Agreement shall not be deemed to confer upon or give to any other third party any remedy, claim liability, reimbursement, cause of action or other right.
- 9.8 Interpretation. The article and section headings contained in this Agreement are solely for the purpose of reference, are not part of the agreement of the parties and shall not in any way affect the meaning or interpretation of this Agreement.
- 9.9 Entire Agreement. This Agreement and the exhibits and other writings referred to herein or delivered pursuant hereto that form a part hereof constitute the entire agreement among the parties with respect to their subject matter and supersede all other prior agreements and understandings, both written and oral, between the parties or any of them with respect to their subject matter.
- 9.10 Governing Law. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Kansas, without regard to its conflict of laws rules or principles.
- 9.11 Counterparts. This Agreement may be executed simultaneously in counterparts, each of which will be deemed an original but all of which together will constitute one and the same instrument.

This is due, in part, to the company's close relationship with Miller's Professional Imaging, which The Finishing Touch serves through its 808 East Jefferson location.

This growth has prompted a need for infrastructure improvements to the 808 East Jefferson facility, which will provide The Finishing Touch with added employment and freight delivery capacity. The improvement project represents a \$250,000 investment by The Finishing Touch, and is expected to add ten new permanent positions. The company's current workforce stands at 35 permanent and 25 seasonal positions.

A considerable portion of the project is the placement of two 42-inch drainage pipes to accommodate stormwater drainage as required by the City. These two pipes represent a cost of approximately \$100,000, which will be the responsibility of The Finishing Touch.

The company recently applied for an economic development incentive package to assist with this project. The Economic Development Advisory Committee (EDAC) considered this request at its October 5, 2022, meeting and voted to allocate \$25,000 in non-repayable funds (predicated on an expected \$250,000 investment by The Finishing Touch) towards the project with the City's funds to be used exclusively for infrastructure improvements.



On August 30, 2022, the Pittsburg Police Department accepted notice from the U.S. Office of Justice Programs that we have been approved for an award amount of \$235,000.00 from the Bureau of Justice Assistance's Fiscal Year 2022 Byrne Discretionary Community Project Funding / Byrne Discretionary Grants Program (re: application no. GRANT13600389).

This award amount was presented to the Police Department as an acquisition project for less lethal law enforcement technology in the form of 55 TASER-7 Electronic Control Weapons (ECW's) from Axon Enterprise, Inc., which will be used to replace the department's current line of eight-year-old TASER X-2 ECW's. Additionally, this project will be used to acquire a series of training aids from Axon Enterprise, Inc., to include a protective training suit for hands-on training with TASER devices, and a Virtual Reality de-escalation training simulator system, including command tablet, headsets, controllers, and VR TASER cartridges.

Axon Enterprise, Inc., is the single-source supplier for TASER Electronic Control Weapons.

This acquisition project will help to assist the Police Department's law enforcement officers during the performance of their sworn duties in safely dealing with aggressive and violent offenders during arrest actions. The training aids (including the Virtual Reality simulator) will further enhance the police department's abilities to train personnel through scenario-based situations to help further develop critical thinking skills, empathy and de-escalation tactics.

The 2022 Byrne Discretionary Community Project Funding / Byrne Discretionary Grants Program has allocated a total of \$235,000.00 to be awarded to the City of Pittsburg / Pittsburg Police Department for this program opportunity, under the heading of Acquisition of less lethal Law Enforcement Technology.

The Police Department is seeking to make use of this funding opportunity as an equipment acquisition project that will greatly improve the overall safety of the Police Department's sworn law enforcement officers in the performance of their official duties while dealing with dangerous, high-risk situations, such as confrontational and combative offenders.

Specifically, the Police Department is seeking to acquire the following articles of equipment through a bundle purchase with TASER's parent company, Axon Enterprise, Inc.:



'THEY LOVE THE TASER 7: HOW ROCK HILL PD ENHANCED CONFIDENCE WITH TASER 7 ENERGY WEAPON



/ A NATURAL TRANSITION FROM THE TASER X2

For Sgt. Lee McKellar of Rock Hill Police Department, staying on the cutting edge of technology helps his agency keep their officers and the community safe. So when his department's TASER X2 energy weapons were approaching the end of their 5-year useful life, he advocated for transitioning to the TASER 7 device.

Making the upgrade was a clear choice for the department, which issues TASER devices to all of its 158 sworn officers. Over the years, the department's TASER energy weapons have consistently proven their value, Sgt. McKellar said, with their presence often enough to de-escalate a situation, making them vital, standard-issue equipment.

According to Sgt. McKellar, the department quickly saw the value of a double-shot device after shifting to the TASER X2 energy weapon in 2014-2015, making the adoption of the TASER 7 energy weapon a natural transition.

"From an officer safety level, it's a no-brainer to move over to [a double-shot TASER energy weapon]," he said, noting that it could take an officer several critical seconds to reload a single-shot device after a miss.

/ CLOSE QUARTER CONFIDENCE

Aside from the advantages of a dual-shot energy weapon, Sgt. McKellar said that TASER 7's Close Quarter cartridges, rechargeable batteries and dock and walk workflow played a major factor in the department's decision to upgrade.

He noted that he had analyzed his agency's previous TASER probe deployments and found that the vast majority occurred within 6 to 8 feet — with a few occurring at around 10 to 12 feet. TASER 7's Close Quarter cartridges, which are optimized for a close-range deployment distance, were a perfect fit for his agency's needs.

"Finally, there's a company listening to the rank-and-file officers saying, 'Hey, you know our TASER contacts are within 6. 7. 8 feet or so,'" he said.

/ STREAMLINED PROGRAM MANAGEMENT

In addition, Sgt. McKellar found that TASER 7's wireless design and new program management enhancements would save him several hours each month — and improve the agency's ability to serve the community.

He uses the Axon Device Manager mobile application to easily assign or re-assign devices and batteries, making assignment "on the fly" with his phone.

Before using the TASER 7's swappable, rechargeable batteries, officers would occasionally report that their TASER X2 batteries had died. If Sgt. McKellar was not at the station, he would have to return from home and switch the battery out. He estimated that the process of getting the officer's call, returning, and swapping out batteries could take up to 90 minutes.

"Given how busy we are with calls for service, to have one person off the road really puts a stress on everybody else out there," Sgt. McKellar said. "Having the freedom and the capability just to grab the battery and go is [invaluable]."

Officers immediately noticed the enhancements during training.

"They were really excited about getting their hands on it," Sgt. McKellar said, noting that the agency spent a significant part of the training unholstering the energy weapon to get familiar with its new holster design and running live scenarios with the HALT suit.

"They love the TASER 7... you can't buy that pride in a piece of equipment," he said, finding that officers appreciate the device because they know that they can depend on it.

/ ONE PREDICTABLE PACKAGE

When the department upgraded, they bundled their TASER 7 energy weapons with Axon Body 3 cameras through the Officer Safety Plan 7+ (OSP 7+) package. The bundle ensures budget predictability for the agency — and resolved previous equipment availability concerns.

"Prior to going into the OSP program, we would buy our cartridges for our [TASER] X2s as needed. We would have our annual training in the fall or spring — you start laying things out and you realize, 'Oh no, I am x amount of cartridges short,' and you submit a request to your chain of command to purchase \$1,500 or \$1,600 worth of cartridges that you didn't anticipate," he said. "It can raise some eyebrows. So with OSP, laying everything out, it's one payment a year spread out over several years, but you're budgeting. You're also saying, 'I know for a fact that I am going to have this many cartridges and this many devices on hand, so I can plan out my training.'"

"It was always a juggling game almost because you were just trying to keep everything in motion, because when people want to go to training, they obviously want to just go ahead and get it done. And for me to come up and say, 'No, you can't go because we don't have enough cartridges,' that would fall back on me... with OSP, it's always there on hand."

Beyond the budgetary and equipment availability benefits of OSP 7+, Sgt. McKellar said that Axon's body cameras and TASER energy weapons go together like "peanut butter and jelly." The two devices help mitigate risk and build trust.

"I really think that you have to have both of those pieces of equipment in today's law enforcement to be out there and to maintain the public trust."

In short, Sgt. McKellar said that adopting TASER 7 energy weapons was just another step toward Rock Hill PD's mission to serve the community by staying at the forefront of technology.

When asked what he would tell an agency considering upgrading, his answer was simple.

"If you're on the fence about it, don't hesitate, go ahead and make that switch over," he said. "You're not going to regret it."





/ DOMESTIC VIOLENCE

Empathy is at the heart of this scenario. Trainees experience inner-dialogue, anxiety and despair firsthand, learn strategies to effectively communicate with victims of trauma and employ questioning techniques to keep all parties safe.

/ AUTISM I

This scenario is amplified by lights and sirens to demonstrate to trainees how police interaction might overwhelm a person living on the autism spectrum. OUR BEST TASER DEVICE EVER

The TASER 7 device is the product of everything we've learned from in-depth discussions with customers and deployments of TASER devices across thousands of agencies worldwide. We focused design enhancements around three key areas: improving performance to help officers de-escalate situations with confidence; enhancing transparency and officer training to help build consensus with communities about why officers need access to TASER devices and reassure them about their usage; and further integrating TASER 7 devices with the Axon network to reduce the cost and time of managing their TASER energy weapon program.

OUR BEST TASER DEVICE EVER

TASER 7 is central to our vision of making the bullet obsolete. With an emphasis on de-escalation, officers can alert subjects to the presence of a TASER 7 energy weapon, draw it, display its lasers and arc the device. Should intervention be required, the device is often the best option officers have to protect themselves, colleagues, the public – and suspects too. Some of the new or enhanced benefits include:

/ COMPENSATING FOR CLOSE PROBE SPREADS

We first introduced 'Adaptive Cross Connect' in the TASER X2 device. It's been completely revamped for the TASER 7, with the device including an algorithm to check and recheck the strength of the various connections between positive and negative probes. This ensures that if an officer has a close probe spread in the first discharge, and the same happens with the second two darts, the device will optimize delivery of the pulse – based on the best balance of positive and negative charge – across the greatest possible spreads.

/ DISCHARGING WITH GREATER POWER AND ACCURACY

A new probe design sees the body of the dart house the wire, with a center-tapped nozzle spiraling the dart to fly straighter and with greater stability to stay on target. Packing the probe with the wire also ensures that it flies 28% faster and impacts with double the kinetic energy to better penetrate thick clothing.

/ OPTIMIZING IMMOBILIZATION

By accelerating electrical pulse delivery and delivering pulses with greater frequency per second, the TASER 7 device can achieve more effective full-body lock-up for complete immobilization.



/ IMPROVING CLOSE-QUARTER PERFORMANCE

The TASER 7 device delivers a 93% increased probe spread at close range (where over 80% of deployments happen, according to agency reports).

/ IMPROVING AIM

A bright green laser helps officers target with greater accuracy, even in sunlight.

/ AN ATTENTION-GRABBING WARNING

A much louder warning arc – accessed by a large, ergonomically-positioned switch – catches attention and helps officers better pacify suspects and defuse situations.

/ TAILORING PERFORMANCE TO INCIDENTS

Officers can choose between stand-off and close-quarters cartridges. The cartridges load using the same fluid and instinctive motion familiar to users of the TASER X2 device. We've also added an innovative connecting configuration, allowing two cartridges to be loaded at once.

MORE REASSURING: BUILDING CONSENSUS WITH COMMUNITIES

Engaging communities to support policing is increasingly important in the fight against crime. And, with violent crime rising in many regions, citizens are more open to equipping police officers with TASER devices. To help in reassuring citizens about the use of TASER 7, the device comes with the option of Axon Signal technology. When a device is armed, Signal alerts nearby Axon cameras – including body-worn, point-of-view and in-vehicle cameras – to begin recording to help capture the full narrative of the incident and your officers' professionalism.

We also provide comprehensive face-to-face training for all officers who carry TASER 7 devices. The training is heavily focused on emphasizing de-escalation. It can be referenced when talking to your community along with statistics that show that use of force incidents are likely to fall – as are injuries to officers and suspects compared to other less-lethal use of force options – when officers carry the devices. We're also producing innovative virtual reality training that presents officers with role-based scenarios to help them better respond to calls involving individuals in crisis or with mental health issues. The training can be taken in bite-sized chunks without the need to take officers away from their duties for any length of time.

MORE CONNECTED: AUTOMATING WORKFLOWS

With the TASER 7, we've helped agencies save hours each month previously spent managing their TASER energy weapon program. This has been achieved by:

/ SEAMLESS DATA LOGGING AND FIRMWARE UPDATES

Similar to how our body-worn cameras work, when officers dock their TASER devices to charge, usage logs are automatically uploaded to Axon Evidence. The process is managed by the smart rechargeable battery. It acts like an encrypted USB drive to transfer data while it's being charged. Firmware updates take place at the same time. This ensures that the next time the battery is plugged into the device, the latest software will be available – replacing a process that could take weeks – with a straightforward and fully automated workflow that frees program managers to spend time on more valuable tasks.

/ AUTOMATING ARMORY

Traditionally, most agencies manage the issuing and receipt of devices using paper-based spreadsheets. To replace this time-consuming workflow, TASER 7 devices automate key armory and admin functions. For example, device assignment can be done in seconds with our Axon Device Manager mobile app by simply scanning a barcode on the device. It's also easier to manage inventory in Axon Evidence with better search and status functions to track and view the status of devices.
