LAND BANK BOARD OF TRUSTEES APPOINTMENT – On motion of McNay, seconded by Hite, the Governing Body appointed William Wachter (Legal Representative) to a first three-year term as a member of the Land Bank Board of Trustees effective immediately and concluding on December 31, 2025. Motion carried.

LAND BANK BOARD OF TRUSTEES APPOINTMENT – On motion of McNay, seconded by Hite, the Governing Body appointed May Smith (Crawford County Representative) to a second three-year term as a member of the Land Bank Board of Trustees effective immediately and concluding on December 31, 2025. Motion carried.

APPROPRIATION ORDINANCE — On motion of McNay, seconded by Hite, the Governing Body approved the Appropriation Ordinance for the period ending January 10, 2023, subject to the release of HUD expenditures when funds are received.
