1. Review/Approve Last Meeting Notes - Action Needed

2. Update on Solid Waste Collection – Troy Graham (Assistant Director of Property and Sanitation) & Kaci Preston (Codes Enforcement Inspector)

- Number of Households Signed up so far 685
- Question/Answer
- Kim informed us that trash and property management / codes enforcement kind of go hand in hand,
 resulting in department mergers
- If it's a codes complaint, it goes to Kaci Preston and she delegates to the appropriate person.
 - Kenny & Josh are the other codes inspectors
 - Once a codes case is open it isn't in SeeClickFix, they will close the SeeClickFix ticket even if the codes ticket is still open in the department system.
- Ryan asked if analytics can be broken down for SeeClickFix
 - Yes
- PJ asked what the biggest problem for codes enforcement is
 - Kaci answered inoperable vehicles
 - She also answered that they'd like to see trash ordinance updated so they only have to send one letter per calendar year before action can be taken
- John Lair asked about trailers parked on the street
 - Kaci said it's likely a PD problem
- Kaci said most work orders are abandoned property
- Troy said that trash pick up has been a problem since people don't know when their trash will be picked up, they leave their cans out for days at a time
- Bob asked if they were going to make trash service mandatory
 - Troy and Kaci are unsure

- Burning plastic can be ticketed directly by the fire department
- Lacy asked if tickets are primarily renters or owners
 - Kaci indicated it's primarily renters
 - Letters are sent to the utility account as well as the property owners information
- Bob asked Troy if landlords can be billed separately for trash service
 - Yes
- Trash bill can be attached to water bill and inside city limits but there's a small potential for it to be extended
- Troy talked briefly about the 50/50 sidewalk program
 - Kristin asked about average price cost
 - Bob said 20-25 feet was \$1100 "several years ago", total cost was \$146
