ORDINANCE NO. G-1372

AN ORDINANCE amending Section 2-137 of the Pittsburg City Code to update and clarify the duties of the City Attorney, municipal judge and the police legal advisor/municipal court prosecutor.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PITTSBURG, KANSAS:

Section 1. Section 2-137 of the Pittsburg City Code is amended to read as follows:

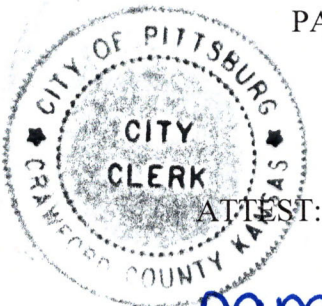
Sec. 2-137. – Department of Law.

The Department of Law is created for the administration of the legal affairs of the City.

- (1) The City Attorney shall perform the duties which are now or hereafter prescribed by law and the ordinances of the City and, in addition, shall perform such other duties as may be assigned by the City Manager in order to effectively carry out the civil legal duties of the department.
- (2) The municipal judge shall preside over all cases filed in municipal court. He or she shall possess and exercise all the powers as conferred and defined by law and ordinances.
- (3) The police legal advisor/municipal court prosecutor shall review all reports and prosecute all cases within the jurisdiction of the municipal court including appeals to District Court, and provide legal and administrative assistance and advice to the Police Department.

Section 2. This Ordinance shall take effect after its passage and publication of its summary in the official city newspaper.
